16	incident stress management and who is certified as a peer support member by		
17	the Arkansas Crisis Response Team qualified to provide emotional or moral		
18	support to an emergency responder who needs emotional or moral support as a		
19	result of job-related stress or an incident in which the emergency responder		
20	was involved while acting in his or her official capacity; and		
21	$\frac{(2)}{(3)}$ "Peer support event" means any debriefing, defusing, or		
22	counseling session conducted by a certified peer support member that involves		
23	the emotional or moral support of an emergency responder who needs emotional		
24	or moral support as a result of job-related stress or an incident in which		
25	the emergency responder was involved while acting in his or her official		
26	capacity.
