7	to add an additional section to read as follows:		
8	20-9-104. Nonparticipation in maintenance of licensure or maintenance		
9	of certification.		
10	(a) As used in this section:		
11	(1) "Maintenance of certification" means any process requiring		
12	periodic recertification examinations or other activities to maintain		
13	specialty medical certification; and		
14	(2) "Specialty medical board certification" means a		
15	certification by a board that:		
16	(A) Specializes in one (1) particular area of medicine;		
17	<u>and</u>		
18	(B) Typically requires examinations that are in addition		
19	to the requirements of the Arkansas State Medical Board to practice medicine.		
20	(b)(1) Except as provided in subdivision (b)(2) of this section, a		
21	healthcare facility licensed by the Department of Health shall not deny		
22	physician hospital staff or admitting privileges or employment based solely		
23	on the absence of maintenance of certification.		
24	(2) Subdivision (b)(1) of this section does not prevent a		
25	healthcare facility from requiring physicians to undergo remedial or		
26	corrective courses or training as required by a quality improvement		
27	committee.

29	SECTION 3. Arkansas Code Title 23, Chapter 85, Subchapter 1, is		
30	amended to add an additional section to read as follows:		
31	23-85-140. Nonparticipation in maintenance of licensure or maintenance		
32	of certification — Insurer prohibited from denying reimbursement or		
33	discriminating in reimbursement levels.		
34	(a) As used in this section:		
35	(1) "Maintenance of certification" means any process requiring		
36	periodic recertification examinations or other activities to maintain		

1	specially medical certification; and
2	(2) "Specialty medical board certification" means a
3	certification by a board that:
4	(A) Specializes in one (1) particular area of medicine;
5	<u>and</u>
6	(B) Typically requires examinations that are in addition
7	to the requirements of the Arkansas State Medical Board to practice medicine.
8	(b) An insurer shall not:
9	(1) Deny reimbursement to or prevent a physician from
10	participating in any provider network based solely on a decision of the
11	physician to not participate in any form of maintenance of certification; and
12	(2) Discriminate with respect to reimbursement levels based
13	solely on a decision of the physician to not participate in any form of
14	maintenance of certification.
