20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:	
21		
22	SECTION 1. Arkansas Code § 1-2-124(c), concerning the use of	
23	respectful language in the Arkansas Code, is amended to read as follows to	
24	remove obsolete language:	
25	(c)(l) In any administrative rule, a state agency shall avoid the	
26	inappropriate terms in subdivision (b)(1) of this section and shall use the	:
27	terms in subdivision (b)(3) of this section.	
28	(2) Each state agency shall review its rules for uses of the	
29	inappropriate terms in subdivision (b)(1) of this section.	
30	$\frac{(3)}{(2)}$ If a state agency identifies a use of an inappropriate	
31	term under subdivision (b)(l) of this section in a rule, the state agency	
32	shall promulgate a revision to the rule to replace the inappropriate term	
33	with a term under subdivision (b)(3) of this section.	
34	(4) Each state agency shall complete the review under	
35	subdivision (c)(2) of this section by January 1, 2012.	
36	$\frac{(5)}{(3)}$ As used in this subsection, "state agency" means any	

1	office, board, commission, department, council, bureau, or other agency of
2	state government having authority by statute enacted by the General Assembly
3	to promulgate or enforce administrative rules.

5	SECTION 2. Arkansas Code Title 1, Chapter 4, is amended to add an
6	additional section to read as follows:
7	1-4-134. State dinosaur.
8	(a) The Arkansaurus fridayi is designated as the official dinosaur of
9	the State of Arkansas.
10	(b)(l) This section does not require a state agency or office to
11	republish a publication or brochure to list or display the state dinosaur.
12	(2) A state agency or office may include information concerning
13	the state dinosaur in a future publication or brochure or in a scheduled
14	update to a publication or brochure.
15	
16	SECTION 3. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.
17	It is the intent of the General Assembly that:
18	(1) The enactment and adoption of this act shall not expressly
19	or impliedly repeal an act passed during the regular session of the Ninety-
20	Second General Assembly;
21	(2) To the extent that a conflict exists between an act of the
22	regular session of the Ninety-Second General Assembly and this act:
23	(A) The act of the regular session of the Ninety-Second
24	General Assembly shall be treated as a subsequent act passed by the General
25	Assembly for the purposes of:
26	(i) Giving the act of the regular session of the
27	Ninety-Second General Assembly its full force and effect; and
28	(ii) Amending or repealing the appropriate parts of
29	the Arkansas Code of 1987; and
30	(B) Section 1-2-107 shall not apply; and
31	(3) This act shall make only technical, not substantive, changes
32	to the Arkansas Code of 1987.
