5	for schools that have engaged in collective bargaining to the amount of daily
6	planning period required, is repealed.
7	(C) A school district shall be exempt from the provisions
8	of this subdivision (a)(2) if it has collectively negotiated a contract
9	through a local teachers' association and the collectively negotiated
10	contract expressly provides for a teacher's daily planning period.

12	SECTION 3. Arkansas Code § 6-17-202 is repealed.
13	6-17-202. Applicability.
14	(a) The provisions of this subchapter shall not apply in any school
15	district which chooses to officially recognize in its policies an
16	organization representing the majority of the teachers of the school district
17	for the purpose of negotiating personnel policies, salaries, and educational
18	matters of mutual concern under a written policy agreement.
19	(b) School district boards of directors or their representatives shall
20	not take or threaten actions which interfere with, restrain, or coerce a
21	teacher in the exercise of the teacher's right to have an organization
22	represent a majority of the teachers as set forth in this section.
23	
24	SECTION 4. Arkansas Code § 6-17-209(f), concerning the status of an
25	interim personnel policy committee when a school district consolidates with a
26	school district that has engaged in collective bargaining, is repealed.
27	(f) In the event a school district with a personnel policy committee
28	consolidates with another school that recognizes in its policies an
29	organization representing the majority of the teachers of the school district
30	for the purpose of negotiating personnel policies, salaries, and educational
31	matters of mutual concern pursuant to § 6-17-202, each teacher in the school
32	district with the personnel policy committee shall have the right in his or
33	her first year of employment with the new school district to elect to have
34	his or her contract governed by the negotiated personnel policies of the new
35	school district or to continue with the terms of his or her existing contract
36	under the personnel policies of the school district by which he or she was
