26	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the Gen	eral	
27	Assembly, that funds provided by the General Assembly for the operations	<u>of</u>	
28	the Department of Finance and Administration - Building Authority Division	<u>n</u>	
29	are, due to unforeseen circumstances, insufficient for the Department of		
30	Finance and Administration - Building Authority Division to continue to		
31	provide essential governmental services; that the provisions of this act	will	
32	provide the necessary monies for the Department of Finance and Administra	tion	
33	- Building Authority Division to continue such services; and that a delay	in	
34	the effective date of this Act could work irreparable harm upon the prope	<u>r</u>	
35	administration and provision of essential governmental programs. Therefor	e,	

an emergency is hereby declared to exist and this Act being necessary for the

1	immediate preservation of the public peace, health and safety shall be in
2	full force and effect from and after the date of its passage and approval.
3	If the bill is neither approved nor vetoed by the Governor, it shall
4	become effective on the expiration of the period of time during which the
5	Governor may veto the bill. If the bill is vetoed by the Governor and the
6	veto is overridden, it shall become effective on the date the last house
7	overrides the veto.
