- (b) The \underline{A} teacher or classified employee may request <u>under subdivision</u>

 (a)(1) of this section a lump-sum deduction or have the sum to be deducted spread over the school year.
 - (c) The A public school district board of directors, or its authorized representative, shall transmit the sum deducted to the organizations designated by the teacher or classified employee in the his or her request under subdivision (a)(1) of this section.
- (d) All requests <u>under subdivision (a)(1) of this section</u> shall bear the manual signature of the teacher or classified employee.
 - (e) The \underline{A} request under subdivision (a)(1) of this section shall be filed with the contract of the teacher or classified employee and shall be subject to audit by Arkansas Legislative Audit.
 - (f) As used in this section:
 - (1) "Classified employee" means \underline{any} \underline{a} person employed by a \underline{public} school district under a written annual contract \underline{and} who is not required to have a teaching license issued by the Department of Education as a condition of employment; and
 - (2) "Teacher" means any a person, including without limitation a superintendent and assistant superintendent, holding a license issued by the State of Arkansas and employed by a <u>public</u> school district in a teaching, instructional, supervisory, administrative, or educational and scientific capacity.
