24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26	SECTION 1. Arkansas Code § 20-10-2304(c), concerning the rules	by the		
27	State Board of Health regarding personal care service providers and pr	ivate		
28	care agencies, is amended to read as follows:			
29	(c) The board shall <u>:</u>			
30	(1) establish Establish a separate licensure category for	•		
31	private care agencies that provide personal care services twenty-four	(24)		
32	hours a day and seven (7) days a week <u>;</u>			
33	(2) Require that:			
34	(A)(i) A qualified supervisor shall establish the			
35	frequency of in-person supervisory visits as part of the patient's pla	un of		
36	care based on the specific needs of the patient and the recommendation	ıs of		

T	the registered nurse.
2	(ii) The frequency of in-person visits shall be at
3	least annually; and
4	(B) A private care agency maintain a primary location in
5	Arkansas and a sufficient number of regional offices to adequately service
6	the administrative needs of the private care agency and the patients of the
7	private care agency; and
8	(3) Not require:
9	(A) A registered nurse to visit a patient every sixty-two
10	(62) days to supervise services; or
11	(B) A branch office of a private care agency to be within
12	a fifty-mile radius of a patient's home.
13	
14	SECTION 2. DO NOT CODIFY. Advisory Private Care Agency Rule Working
15	Group.
16	(a) There is created the Advisory Private Care Agency Rule Working
17	Group within the Department of Health.
18	(b) The group shall consist of the following individuals appointed by
19	the Director of the Department of Health:
20	(1) One (1) member from a list of individuals provided by the
21	HomeCare Association of Arkansas; and
22	(2) Four (4) members from a list of individuals provided by
23	private care agencies.
24	(c)(l) The director shall call the first meeting of the group.
25	(2) The group shall select a chair from the membership at the
26	first meeting.
27	(d) Within sixty (60) days of the effective date of this act, the
28	group shall review the rules regarding private care agencies and make
29	recommendations to the Department of Health for changes to the rules
30	regarding private care agencies to make the rules consistent with rules
31	regarding private care agencies in the surrounding states.
32	(e) On or before November 1, 2019, the group shall provide a report on
33	their review and recommendations described in subsection (d) of this section
34	to:
35	(1) The director;
36	(2) The Governor; and

2	<u>(f)</u>	The members shall not receive expense reimbursement, per diem,	or
3	stipends.		
4	<u>(g)</u>	This section shall expire on November 1, 2019.
