22	SECTION 1. Arkansas	Code § 27-16-915(b)(1), cor	ncerning the suspension
23	of a person's driver's license for possessing a controlled substance, is		
24	amended to read as follows	:	
25	(b)(1)(A) When a pe	rson is accepted and enrolle	ed in a court-approved
26	pre-adjudication specialty	court program for an offens	se involving the illegal
27	possession or use of a con	trolled substance, pleads gu	uilty or nolo
28	contendere, or is found gu	ilty of any criminal offense	e involving the illegal
29	possession or use of contro	olled substances under the U	Jniform Controlled
30	Substances Act, § 5-64-101	et seq., or of any drug off	fense, in this state or
31	any other state, the court	having jurisdiction of the	matter, including any

5	(B) Courts within the State of Arkansas shall may prepare		
6	and transmit to the department an order within twenty-four (24) hours after		
7	the:		
8	(i) Plea of guilty or nolo contendere;		
9	(ii) Finding of guilt; or		
10	(iii) Acceptance and enrollment in a specialty		
11	court.		
12	(C) Courts outside Arkansas having jurisdiction over a		
13	person holding driving privileges issued by the State of Arkansas $\frac{1}{2}$		
14	prepare and transmit an order pursuant to <u>under</u> an agreement or arrangement		
15	entered into between that state and the Director of the Department of Financ		
16	and Administration.		
17	(D) The agreement or arrangement may also provide for the		
18	forwarding by the department of an order issued by a court within this state		
19	to the state where the person holds driving privileges issued by that state.
