

2	(b) For driver's license revocation, the court must provide the		
3	department with the debtor's <u>person's</u> full name, social security <u>Social</u>		
4	Security number, and last known address.		
5	(c) For motor vehicle registration revocation, the court must provide		
6	the department with the debtor's person's full name and the license plate		
7	number or vehicle identification number of the debtor's vehicle.		
8			
9	SECTION 2. DO NOT CODIFY. <u>Effective date.</u>		
10	(a) This act is effective ninety (90) days after funding is secured		
11	through an appropriation from the General Assembly that specifically states		
12	that the appropriation is intended to replace in full the estimated annual		
13	loss under this act in driver's license reinstatement fee revenue as		
14	calculated by the Department of Finance and Administration.		
15	(b) The department shall notify the Legislative Council, the Arkansas		
16	Code Revision Commission, and the Director of the Bureau of Legislative		
17	Research within thirty (30) days of the required funding being secured.
