28	SECTION 1. DO N	OT CODIFY. <u>Purpose.</u>	
29	The purpose of t	his act is to clarify the law conc	erning the collection
30	of sales tax and touri	sm tax and to clarify the services	for which the sales
31	tax and tourism tax ar	e owed.

33	SECTION 2. Arka	nsas Code \S 26-52-301(3)(A), conce	erning the gross
34	receipts tax levied on	certain products and services, is	amended to read as
35	follows:		
36	(A)(i) Service of furnishing rooms, s	uites, condominiums,

1	townhouses, rental houses, of other accommodations by hotels, apartment		
2	hotels, lodging houses, tourist camps, tourist courts, property management		
3	companies, accommodations intermediaries, or any other provider of		
4	accommodations to transient guests.		
5	(ii) As used in subdivision (3)(A)(i) of this		
6	section , "transient :		
7	(a) "Accommodations intermediary" means a		
8	person other than the owner, operator, or manager of a room, suite,		
9	condominium, townhouse, rental house, or other accommodation;		
10	(b) "Furnishing" means brokering,		
11	coordinating, making available for, or otherwise arranging for the sale or		
12	use of a room, suite, condominium, townhouse, rental house, or other		
13	accommodation by a purchaser; and		
14	(c) "Transient guests" means those individuals		
15	who rent accommodations other than their regular place of abode on less than		
16	a month-to-month basis;

18	SECTION 3. Arkansas Code § 26-52-501, concerning the preparation of		
19	returns and payment of sales tax, is amended to add an additional subsection		
20	to read as follows:		
21	(k) A person that collects a tax under this chapter shall remit the		
22	tax to the state in accordance with this subchapter.		
23			
24	SECTION 4. Arkansas Code § 26-63-402(1), concerning the tourism tax		
25	imposed on certain goods and services, is amended to read as follows:		
26	(1)(A) The service of furnishing a:		
27	(i) Condominium, townhouse, or rental house to a		
28	transient guest; and		
29	(ii) Guest room, suite, or other accommodation by a		
30	hotel, motel, lodging house, tourist camp, tourist court, property management		
31	company, an accommodations intermediary, or any other provider of an		
32	accommodation to a transient guest.		
33	(B) As used in this subdivision (1), "transient:		
34	(i) "Accommodations intermediary" means a person		
35	other than the owner, operator, or manager of a room, suite, condominium,		
36	townhouse rental house or other accommodation.		

1	(ii) "Furnishing" means brokering, coordinating,		
2	making available for, or otherwise arranging for the sale or use of a room,		
3	suite, condominium, townhouse, rental house, or other accommodation by a		
4	purchaser; and		
5	(iii) "Transient guest" means a person that rents an		
6	accommodation, other than the person's regular place of abode, on less than a		
7	month-to-month basis;
