25	no two (2) commission	ers be appointed from a single congress	sional district;

28	WHEREAS, the co	ngressional districts in the state have	e been subject to	
29	redistricting since t	he enactment of Arkansas Constitution,	Amendment 42; and

31	WHEREAS, the in	tent of the requirement under Arkansas	Constitution,	
32	Amendment 42, that no two (2) members be appointed from a single			
33	congressional district was to assure equal representation on the commission			
34	of all parts of the s	tate; and

36	WHEREAS, to acc	omplish the intent of Arkansas Constitu	ution, Amendment	

1	42, concerning the appointment of the commission members, it is necessary
2	that the General Assembly enact legislation to clarify the residency
3	requirements for persons appointed to the commission,
4	
5	NOW THEREFORE,
6	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
7	
8	SECTION 1. Arkansas Code § 27-65-104(a), concerning the members
9	appointed to the State Highway Commission, is amended to read as follows:
10	(a) All appointments to the State Highway Commission shall be based
11	upon the four (4) congressional districts as defined on July 20, 1979.
12	Appointments All appointments to the commission State Highway Commission
13	shall be made so as to assure that, at the earliest possible date, the
14	commission shall be composed of:
15	$\underline{\text{(1)}}$ one $\underline{\text{One}}$ (1) member from each of the four (4) congressional
16	districts as the districts exist at the time of a member's appointment; and
17	(2) one \underline{One} (1) member from the state at large.
