25	(a)(1)(A) Whenever, due to an emergency resulting from the effects of
26	enemy attack, or the anticipated effects of a threatened enemy attack, it
27	becomes imprudent, inexpedient, or impossible to conduct the affairs of local
28	government at the regular or usual place thereof, the governing body of each
29	political subdivision of this state may meet at any place in the county
30	whether within or without the territorial limits of the political
31	subdivisions on the call of the presiding officer or any two (2) members of
32	the governing body.
33	(B) The governing body shall proceed to establish and
34	designate by ordinance, resolution, or other manner alternate or substitute

- 2 (2) The sites or places may be <u>in the county whether</u> within or 3 without the territorial limits of the political subdivisions <del>and may be</del> 4 within or without this state.
  - (b)(1) During the period when the public business is being conducted at an emergency temporary location, the governing body and other officers of a political subdivision of this state shall have and possess and shall exercise at the location all of the executive, legislative, and judicial powers and functions conferred upon the governing body and officers by or under the laws of this state.
  - (2) The powers and functions of the governing body and officers may be exercised without regard to or compliance with time-consuming procedures and formalities prescribed by law and pertaining thereto. All acts of the governing body and officers shall be as valid and binding as if performed within the territorial limits of their political subdivision.

- General Assembly of the State of Arkansas that there are meeting places of governing bodies across the state that are in disrepair; that often a meeting place needs to be closed and relocated temporarily; and that this act is immediately necessary because under current law a meeting place cannot be set up temporarily unless an emergency arises due to an enemy attack. Therefore, an emergency is declared to exist, and this act being immediately necessary for the preservation of the public peace, health, and safety shall become effective on:
