| 31 | (a) As used in this section, "record" means to photograph, make, |

| 34 | reproduced visual image or material. |
| 35 | (b) It is unlawful for a person who is required to register under the |
| 36 | Sex Offender Registration Act of 1997, § 12-12-901 et seq., and who has been |
