BE IT RESOLVED BY THE SENATE OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE

22

STATE OF ARKANSAS, AND BY THE HOUSE OF REPRESENTATIVES, A MAJORITY OF ALL

23

MEMBERS ELECTED TO EACH HOUSE AGREEING THERETO:

THAT the following is proposed as an amendment to the Constitution of

26

the State of Arkansas, and upon being submitted to the electors of the state

27

for approval or rejection at the next general election for Representatives

28

and Senators, if a majority of the electors voting thereon at the election

29

adopt the amendment, the amendment shall become a part of the Constitution of

30

the State of Arkansas, to wit:

SECTION 1. Arkansas Constitution, Amendment 73, § 2, is amended to

read as follows:

§ 2. Legislative Branch.

35

(a) The Arkansas House of Representatives shall consist of members to

36

be chosen every second year by the qualified electors of the several



1 counties.

2 (b) The Arkansas Senate shall consist of members to be chosen every
3 four years by the qualified electors of the several districts.

4 (c)(1) A Except as provided in subdivision (c)(5) of this section, a
5 member of the General Assembly shall serve no more than ~~sixteen (16)~~ twelve
6 (12) years, whether consecutive or nonconsecutive.

7 (2) A Except as provided in subdivision (c)(5) of this section,
8 a member who completes his or her sixteenth year of service during a term of
9 office for which he or she has been elected may serve until the completion of
10 that term of office of the General Assembly shall not be elected to any term
11 which, if served, would cause the member to exceed twelve (12) years of
12 service in the General Assembly.

13 (3) The years of service in both the Senate and the House of
14 Representatives shall be added together and included to determine the total
15 number of years in office.

16 (4) A partial legislative term served as a result of a special
17 election under Article 5, § 6, or a two-year term served as a result of
18 apportionment of the Senate shall not be included in calculating the total
19 number of years served by a member of the General Assembly.

20 (5)(A) A member of the General Assembly who serves twelve (12)
21 years in the General Assembly shall not be eligible for subsequent service in
22 the General Assembly until ten (10) years after the expiration of the last
23 term of office in the General Assembly for which he or she was elected.

24 (B) Subsequent service in the General Assembly under
25 subdivision (c)(5)(A) of this section shall not exceed twelve (12) years,
26 whether consecutive or nonconsecutive.

27

28 SECTION 2. APPLICATION OF AMENDMENT. This amendment shall not cut
29 short or invalidate a term for which a member of the House of Representatives
30 or Senate was elected at the 2020 general election.

32 SECTION 3. BALLOT TITLE AND POPULAR NAME. When this proposed
33 amendment is submitted to the electors of this state on the general election
34 ballot:
