34        *ADMINISTRATION - CONTINGENCY APPROPRIATION TRANSFER AUTHORITY. The Chief*

35        *Fiscal Officer of the State shall transfer appropriation as needed from the*

12 OF RACING - EXTRA HELP. There is hereby authorized, for the Department of  
13 Finance and Administration - Division of Racing for the ~~2019-2020~~ 2020-2021  
14 fiscal year, the maximum number of thirty-one (31) part-time or temporary  
15 employees, to be known as "Extra Help", payable from funds appropriated  
16 herein for such purposes, such employees shall be authorized to work over  
17 1,000 hours per year.

21 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS  
23 TOBACCO CONTROL - PROMOTIONAL ITEMS. Arkansas Tobacco Control is hereby  
24 authorized to purchase from Maintenance & General Operations Classifications  
25 in the Operations Appropriation and Sales to Minors Enforcement - Cash  
26 Appropriation provided by this Act, up to an amount not to exceed \$5,000 each  
27 fiscal year for promotional items, authorized by the Director of the Agency,  
28 and with the approval of the Chief Fiscal Officer of the State, to meet  
29 Arkansas Tobacco Control Merchant Education needs.

30 The provisions of this section shall be in effect only from July 1, ~~2019~~  
31 2020 through June 30, ~~2020~~ 2021.

32

33 SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
34 authorized by this act shall be limited to the appropriation for such agency  
35 and funds made available by law for the support of such appropriations; and  
36 the restrictions of the State Procurement Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
2 Procedures and Restrictions Act, or their successors, and other fiscal  
3 control laws of this State, where applicable, and regulations promulgated by  
4 the Department of Finance and Administration, as authorized by law, shall be  
5 strictly complied with in disbursement of said funds.

6  
7 SECTION 25. LEGISLATIVE INTENT. It is the intent of the General  
8 Assembly that any funds disbursed under the authority of the appropriations  
9 contained in this act shall be in compliance with the stated reasons for  
10 which this act was adopted, as evidenced by the Agency Requests, Executive  
11 Recommendations and Legislative Recommendations contained in the budget  
12 manuals prepared by the Department of Finance and Administration, letters, or  
13 summarized oral testimony in the official minutes of the Arkansas Legislative  
14 Council or Joint Budget Committee which relate to its passage and adoption.

15  
16 SECTION 26. EMERGENCY CLAUSE. It is found and determined by the  
17 General Assembly, that the Constitution of the State of Arkansas prohibits  
18 the appropriation of funds for more than a one (1) year period; that the  
19 effectiveness of this Act on July 1, 2020 is essential to the operation of  
20 the agency for which the appropriations in this Act are provided, and that in  
21 the event of an extension of the legislative session, the delay in the  
22 effective date of this Act beyond July 1, 2020 could work irreparable harm  
23 upon the proper administration and provision of essential governmental  
24 programs. Therefore, an emergency is hereby declared to exist and this Act  
25 being necessary for the immediate preservation of the public peace, health  
26 and safety shall be in full force and effect from and after July 1, 2020.
