SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 18 19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GENERALS 20 SALARY. The line item maximums for the State of Arkansas Adjutant General and 21 Deputy Adjutant General are based on the salary grid by the United States 22 Department of Defense. Incumbents in these positions shall be compensated in 23 accordance with the Department of Defense Advisory Service Pay Plan and are 24 not guaranteed placement at the maximum level. The line item maximum 25 salaries may be adjusted on July 1 of each fiscal year to incorporate salary 26 rate changes that have been implemented by the U.S. Department of Defense. 27 The provisions of this section shall be in effect only from July 1, 2019 28 2020 through June 30, <del>2020</del> 2021.

30 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 32 PROMOTIONAL ITEMS. The State Military Department is hereby authorized to 33 transfer appropriation from Operating Expenses to Promotional Items in the 34 General Operations Appropriation and/or Cash Operations Appropriation 35 provided by this Act in an amount not to exceed ten thousand dollars 36 (\$10,000) each fiscal year, as authorized by the Director of State Resources,

1 and with the approval of the Chief Fiscal Officer of the State.

2 The provisions of this section shall be in effect only from July 1, 2019
3 2020 through June 30, 2020 2021.

5 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE
6 ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
7 CARRY FORWARD OF FUNDS.

8 (a) The Chief Fiscal Officer of the State shall cause to be transferred 9 on his or her books and those of the State Treasurer and Auditor of State the 10 balance of funds remaining in the Department of Military Fund Account on June 11 30, <del>2020</del> <u>2021</u> into a sub-fund created within the Department of Military Fund 12 to be used exclusively for construction, maintenance and operating expenses 13 or for future construction projects of the State Military Department.

(b) Any carry forward of unexpended balance of funding as authorizedherein, may be carried forward under the following conditions:

(1) The Office of Budget of the Department of Finance and
Administration shall report to the Legislative Council all amounts carried
forward by the September meeting of the Legislative Council or the Joint
Budget Committee meeting which report shall include the name of the agency,
board, commission, or institution and the amount of funding carried forward,
the program name or line item and the funding source; and

(2) The State Military Department shall provide a written report
to the Legislative Council or Joint Budget Committee containing all
information set forth in subdivision (b)(1) of this section no later than
thirty (30) days prior to the time the Department presents its budget request
to the Legislative Council or Joint Budget Committee, or both; and

(3) Thereupon, the Department of Finance and Administration shall
include all information obtained in subdivision (b)(2) of this section in the
budget manuals.

30 The provisions of this section shall be in effect only from July 31 1, 2019 2020 through June 30, 2020 2021.

33 SECTION 21. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 34 authorized by this act shall be limited to the appropriation for such agency 35 and funds made available by law for the support of such appropriations; and 36 the restrictions of the State Procurement Law, the General Accounting and

7 SECTION 22. LEGISLATIVE INTENT. It is the intent of the General 8 Assembly that any funds disbursed under the authority of the appropriations 9 contained in this act shall be in compliance with the stated reasons for 10 which this act was adopted, as evidenced by the Agency Requests, Executive 11 Recommendations and Legislative Recommendations contained in the budget 12 manuals prepared by the Department of Finance and Administration, letters, or 13 summarized oral testimony in the official minutes of the Arkansas Legislative 14 Council or Joint Budget Committee which relate to its passage and adoption. 15

16 SECTION 23. EMERGENCY CLAUSE. It is found and determined by the 17 General Assembly, that the Constitution of the State of Arkansas prohibits 18 the appropriation of funds for more than a one (1) year period; that the 19 effectiveness of this Act on July 1, 2020 is essential to the operation of 20 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 21 22 effective date of this Act beyond July 1, 2020 could work irreparable harm 23 upon the proper administration and provision of essential governmental 24 programs. Therefore, an emergency is hereby declared to exist and this Act 25 being necessary for the immediate preservation of the public peace, health 26 and safety shall be in full force and effect from and after July 1, 2020. 27 28 29 30 31 32 33 34
