22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

31 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER

33 OF FUNDS - JUSTICE BUILDING OPERATIONS ACTUAL EXPENDITURES. Building

34 Authority Division may from time to time as may be necessary and in such

35 amounts as may be necessary and with the approval of the Chief Fiscal Officer

36 of the State, request a transfer of funds from the State Central Services

1 Fund to the Arkansas Building Authority Maintenance Fund for operation of the  
2 Justice Building for actual expenditures, in an amount not to exceed the  
3 dollar amount appropriated in the Justice Building Operation Section. Upon  
4 his approval, the Chief Fiscal Officer of the State shall then initiate the  
5 necessary transfer documents to reflect the transfer upon the fiscal records  
6 of the State Auditor, the State Treasurer, the Chief Fiscal Officer of the  
7 State and Building Authority Division.

8 The provisions of this section shall be in effect only from July 1, ~~2019~~  
9 2020 through June 30, ~~2020~~ 2021.

10  
11 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
13 OF FUNDS. Building Authority Division is hereby authorized, after seeking  
14 the approval of the Chief Fiscal Officer of the State and the Arkansas  
15 Legislative Council or Joint Budget Committee to request transfer from the  
16 appropriation made in the Building Maintenance Section for Building  
17 Maintenance to the Acquisition and Maintenance appropriation in the  
18 Acquisition and Maintenance Section and to receive from another state agency  
19 that seeks like approvals its authority, appropriation and the transfer of  
20 funds to be deposited into the Building Authority Division Real Estate Fund  
21 to become part of the Acquisition and Maintenance appropriation, and to be  
22 used for any purposes as set forth by law for said Real Estate Fund.

23 Determining the maximum number of employees and the maximum amount of  
24 appropriation and general revenue funding for a state agency each fiscal year  
25 is the prerogative of the General Assembly. This is usually accomplished by  
26 delineating such maximums in the appropriation act(s) for a state agency and  
27 the general revenue allocations authorized for each fund and fund account by  
28 amendment to the Revenue Stabilization law. Further, the General Assembly  
29 has determined that Building Authority Division may operate more efficiently  
30 if some flexibility is provided to Building Authority Division authorizing  
31 broad powers under this section. Therefore, it is both necessary and  
32 appropriate that the General Assembly maintain oversight by requiring prior  
33 approval of the Legislative Council or Joint Budget Committee as provided by  
34 this section. The requirement of approval by the Legislative Council or  
35 Joint Budget Committee is not a severable part of this section. If the  
36 requirement of approval by the Legislative Council or Joint Budget Committee



1 is ruled unconstitutional by a court of competent jurisdiction, this entire  
2 section is void.

3 The provisions of this section shall be in effect only from July 1, ~~2019~~  
4 2020 through June 30, ~~2020~~ 2021.

6 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
7 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUILDING  
8 AUTHORITY DIVISION CONTINGENCY APPROPRIATION TRANSFER AUTHORITY. Building  
9 Authority Division may transfer appropriation and funds as needed from the  
10 Facilities Management Contingency Appropriation in the Building Maintenance  
11 Section of this Act to any appropriation authorized for Building Authority  
12 Division.

13 The provisions of this section shall be in effect only from July 1, ~~2019~~  
14 2020 through June 30, ~~2020~~ 2021.

15

16 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
18 TO FACILITIES MANAGEMENT CONTINGENCY APPROPRIATION AUTHORITY. (a) In order to  
19 provide a more cost effective method to address the emerging infrastructure  
20 needs of Arkansas State Government, appropriations and funds transferred to  
21 the Facilities Management Contingency Appropriation are to be used in the  
22 event that the Building Authority Division executes one or more building  
23 contracts or maintenance agreements with State Agencies, and the  
24 appropriations or funds otherwise provided for the Building Authority  
25 Division are not sufficient to address those needs, and it is more cost  
26 effective for Building Authority Division to execute these services. Any  
27 State Agency may transfer or deposit funds and appropriations to Building  
28 Authority Division - Facilities Management Contingency Appropriation  
29 authorized in the Building Maintenance Section of this Act to execute one or  
30 more building contracts or maintenance agreements with said State Agencies.  
31 Building Authority Division shall provide justification to the Chief Fiscal  
32 Officer of the State for the need of such appropriations and funds transfers  
33 and seek and receive approval of the Chief Fiscal Officer of the State.  
34 Building Authority Division shall then seek and receive the approval of the  
35 Arkansas Legislative Council or Joint Budget Committee. The requirement of  
36 approval by the Arkansas Legislative Council or Joint Budget Committee is not

1 a severable part of the section. If the requirement of approval by the  
2 Arkansas Legislative Council or Joint Budget Committee is ruled  
3 unconstitutional by a court of competent jurisdiction, this entire section is  
4 void.

5 (b) The Chief Fiscal Officer of the State shall make the necessary  
6 adjustments on his or her books and the books of the Auditor of the State for  
7 the transfer or deposit of the funds and appropriations from each State  
8 Agency to the appropriation authorized in the Building Maintenance Section of  
9 this Act and to the various Building Authority Division accounts to be used  
10 exclusively by Building Authority Division for the fiscal year.

11 The provisions of this section shall be in effect only from July 1, ~~2019~~  
12 2020 through June 30, ~~2020~~ 2021.

13

14 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

16 SUSTAINABLE BUILDING DESIGN PROGRAM - TRANSFER. In the event there is not  
17 sufficient appropriation and/or funding provided for by the General Assembly  
18 for any state agency, board or commission to participate in the Sustainable  
19 Building Design Program for renovations of state owned property which exceeds  
20 two hundred fifty thousand dollars (\$250,000), the agency may request a  
21 transfer from the Sustainable Building Design Program appropriation  
22 authorized in the Sustainable Building Design Program Section of this Act  
23 from the Chief Fiscal Officer of the State. The request shall clearly state  
24 the amount required and such other information as may be required by the  
25 Chief Fiscal Officer of the State necessary to make a decision regarding the  
26 request. Upon approval of the Chief Fiscal Officer of the State and prior  
27 review by the Arkansas Legislative Council or Joint Budget Committee, the  
28 State Auditor shall be notified as of the amount and the purposes for which  
29 the appropriation and/or funding is to be transferred and shall be  
30 established upon the books of the Department of Finance and Administration  
31 and the State Auditor. If desired, the appropriation may be supplemental to  
32 those regularly appropriated for like purposes by the General Assembly for  
33 that agency.

34 Provided further, that all state agencies, boards or commissions shall  
35 have prior approval by the Building Authority Division as authorized for the  
36 Sustainable Building Design Program in accordance with established Rules and

1 Regulations.

2 The provisions of this section shall be in effect only from July 1, 2019  
3 2020 through June 30, ~~2020~~ 2021.

4  
5 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
7 SUSTAINABLE BUILDING DESIGN PROGRAM - REVOLVING LOAN FUND. The Sustainable  
8 Building Design Program Appropriation is intended to provide additional  
9 appropriation authority for the Sustainable Building Design Program. Funding  
10 for the program may be made available by the Chief Fiscal Officer of the  
11 State, in the form of a loan, from a transfer from the Sustainable Building  
12 Design Revolving Loan Fund after the required review by the Arkansas  
13 Legislative Council or Joint Budget Committee, approval by the Chief Fiscal  
14 Officer of the State and approval through rules and regulations established  
15 and administered by Building Authority Division. Moneys made available for  
16 the repayment of a loan shall be deposited to the credit of the Sustainable  
17 Building Design Revolving Loan Fund as a "Refund to Expenditure" for the year  
18 in which the deposit is made. In the event that the funds for the repayment  
19 of a loan are held in depositories other than the State Treasury, the  
20 administrative head of the affected state agency shall issue a check drawn  
21 against the funds, which shall be deposited in the Sustainable Building  
22 Design Revolving Loan Fund.

23 The provisions of this section shall be in effect only from July 1, 2019  
24 2020 through June 30, ~~2020~~ 2021.

25  
26 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING  
28 TRANSFER - GENERAL IMPROVEMENT FUNDS. The Chief Fiscal Officer of the State  
29 may transfer from time to time on his or her books and those of the State  
30 Treasurer and the Auditor of the State funding which is made available from  
31 General Improvement Funds allocated and distributed to Building Authority  
32 Division in an amount not to exceed three million dollars (\$3,000,000) from  
33 the General Improvement Fund or its successor fund or fund accounts to the  
34 Sustainable Building Design Revolving Loan Fund to provide funds for the  
35 appropriation provided herein or for appropriation authority as may be  
36 provided by law to provide loans to agencies for the Sustainable Building

1 Design Program.

2 The provisions of this section shall be in effect only from July 1, ~~2019~~  
3 2020 through June 30, ~~2020~~ 2021.

4  
5 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING  
7 TRANSFER - FEDERAL FUNDS. From time to time, the Chief Fiscal Officer of the  
8 State may transfer on his or her books and those of the State Treasurer and  
9 the Auditor of the State the sum not to exceed twelve million dollars  
10 (\$12,000,000) from Federal Funds as determined by the Chief Fiscal Officer of  
11 the State to the Sustainable Building Design Revolving Loan Fund to provide  
12 funds for the appropriations herein.

13 The provisions of this section shall be in effect only from July 1, ~~2019~~  
14 2020 through June 30, ~~2020~~ 2021.

16 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING  
18 TRANSFER - CASH FUND ACCOUNT. Building Authority Division is authorized to  
19 transfer any unspent funds remaining in any cash fund account established for  
20 the management of a state owned facility managed by, but not owned by,  
21 Building Authority Division to the Building Authority Maintenance Fund to  
22 support the facility's Maintenance and Operations appropriations.

23 The provisions of this section shall be in effect only from July 1, ~~2019~~  
24 2020 through June 30, ~~2020~~ 2021.

25  
26 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING  
28 TRANSFER - INSURANCE DEPARTMENT TRUST FUND. Building Authority Division may  
29 from time to time as may be necessary and in such amounts as may be necessary  
30 and with the approval of the Chief Fiscal Officer of the State, request a  
31 transfer of funds from the Insurance Department Trust Fund to the Building  
32 Authority Division Real Estate Fund to provide funds for land acquisition and  
33 building construction in an amount not to exceed the dollar amount  
34 appropriated in the Acquisition and Maintenance Section. Upon his approval,  
35 the Chief Fiscal Officer of the State shall then initiate the necessary  
36 transfer documents to reflect the transfer upon the fiscal records of the

1 State Auditor, the State Treasurer, the Chief Fiscal Officer of the State and  
2 Building Authority Division.

3 The provisions of this section shall be in effect only from July 1, 2019  
4 2020 through June 30, ~~2020~~ 2021.

5

6 SECTION 24. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
7 authorized by this act shall be limited to the appropriation for such agency  
8 and funds made available by law for the support of such appropriations; and  
9 the restrictions of the State Procurement Law, the General Accounting and  
10 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
11 Procedures and Restrictions Act, or their successors, and other fiscal  
12 control laws of this State, where applicable, and regulations promulgated by  
13 the Department of Finance and Administration, as authorized by law, shall be  
14 strictly complied with in disbursement of said funds.

15

16 SECTION 25. LEGISLATIVE INTENT. It is the intent of the General  
17 Assembly that any funds disbursed under the authority of the appropriations  
18 contained in this act shall be in compliance with the stated reasons for  
19 which this act was adopted, as evidenced by the Agency Requests, Executive  
20 Recommendations and Legislative Recommendations contained in the budget  
21 manuals prepared by the Department of Finance and Administration, letters, or  
22 summarized oral testimony in the official minutes of the Arkansas Legislative  
23 Council or Joint Budget Committee which relate to its passage and adoption.

24

25 SECTION 26. EMERGENCY CLAUSE. It is found and determined by the  
26 General Assembly, that the Constitution of the State of Arkansas prohibits  
27 the appropriation of funds for more than a one (1) year period; that the  
28 effectiveness of this Act on July 1, 2020 is essential to the operation of  
29 the agency for which the appropriations in this Act are provided, and that in  
30 the event of an extension of the legislative session, the delay in the  
31 effective date of this Act beyond July 1, 2020 could work irreparable harm  
32 upon the proper administration and provision of essential governmental  
33 programs. Therefore, an emergency is hereby declared to exist and this Act  
34 being necessary for the immediate preservation of the public peace, health  
35 and safety shall be in full force and effect from and after July 1, 2020.
