SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 27 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS 29 FAIR HOUSING COMMISSION PROMOTIONAL ITEMS. Upon approval of the Chief Fiscal 30 Officer of the State, the Arkansas Fair Housing Commission is hereby 31 authorized to transfer appropriation from Operating Expenses to Promotional 32 Items in the Education-Trust Appropriation provided by this Act in an amount 33 not to exceed eight thousand dollars (\$8,000) each fiscal year to meet the 34 Commission's educational needs. (a)(1)(A) The Chief Fiscal Officer of the State may create paying

5 accounts on his or her books and on the books of the Treasurer of State and 6 the Auditor of State for the payment of personal services and operating 7 expenses by the Department of the Inspector General. 10 SECTION 19. LEGISLATIVE INTENT. 19 SECTION 20. EMERGENCY CLAUSE. It is found and determined by the 20 General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the 21 22 effectiveness of this Act on July 1, 2020 is essential to the operation of 23 the agency for which the appropriations in this Act are provided, and that in 24 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2020 could work irreparable harm 25 26 upon the proper administration and provision of essential governmental 27 programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health 28 29 and safety shall be in full force and effect from and after July 1, 2020. 30 31 32 33 34
