 27 the Department of Human Services - Division of Developmental Disabilities
 28 Services for the 2020-2021 fiscal year, the following maximum number of part-
 29 time or temporary employees, to be known as "Extra Help", payable from funds
 30 appropriated herein for such purposes: two hundred (200) temporary or part-

 34 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 35 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 36 DEVELOPMENTAL DISABILITIES - GRANTS TO COMMUNITY BASED PROVIDERS. Funds

1 allocated for community-based services under the appropriation for (i) the
2 Grants-in-Aid appropriation in this act, (ii) the Grants/Patient Services
3 Line in the Operations appropriation in this act, and (iii) the Inter-
4 Divisional Programs appropriation in this act, shall be used only to provide
5 services through private community based services licensed or certified by
6 the Arkansas Division of Developmental Disabilities Services (DDS) or
7 licensed or certified by a Provider-Led Arkansas Shared Savings Entity
8 (PASSE). Non-profit community-based programs licensed by the Division of
9 Developmental Disabilities Services are quasi-governmental instrumentalities
10 of the state which provide supports and services to individuals who have a
11 developmental disability or delay, who would otherwise require supports and
12 services through state-operated programs and facilities owned by the State of
13 Arkansas. When licensed providers are involved in delivering services which
14 are Medicaid reimbursable, they must enroll as a provider with the Arkansas
15 Medicaid Program and must bill the Arkansas Medicaid Program for all covered
16 services for eligible individuals.

17 Services which are covered by the Arkansas State Medicaid Program,
18 including the Provider-Led Arkansas Shared Savings Entity (PASSE) model, will
19 be utilized to the maximum extent possible for any individual who is eligible
20 for Medicaid coverage. It is the intent of this section that DDS, as a
21 general policy, maximize the use of Medicaid funding available for
22 appropriate services.

23 Licensed private community providers funded from these appropriations for
24 community based services shall:

- 25 1. Screen each individual to whom services are provided for a determination
26 of eligibility or ineligibility for Medicaid coverage within thirty days of
27 the first date that services are provided.
- 28 2. Meet minimum standards of performance in the delivery of services to
29 people with disabilities as defined by the Department of Human Services -
30 Division of Developmental Disabilities Services.
- 31 3. Supply statistical and financial data to the Department of Human Services
32 - Division of Developmental Disabilities Services.
- 33 4. Establish and maintain a sound financial management system in accordance
34 with guidelines as set forth by the Department of Human Services.
- 35 5. Establish and maintain community support programs designed to provide
36 coordinated care and treatment to ensure ongoing involvement and

1 individualized services for persons with disabilities.

2 It is the intent of this section to insure that wherever possible and
3 appropriate, Medicaid funds are utilized.

4 Nothing in this Act shall prevent the Division or any provider from
5 extending emergency services when appropriate measures have been taken in a
6 timely manner to secure Medicaid eligibility.

7 The provisions of this section shall be in effect only from July 1, ~~2019~~
8 2020 through June 30, ~~2020~~ 2021.

9
10 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
12 DEVELOPMENTAL DISABILITIES - VOCATIONAL TRAINEES. The Division of
13 Developmental Disabilities Services of the Department of Human Services is
14 hereby authorized to provide employment opportunities for people with
15 developmental disabilities residing at the Human Development Centers who work
16 at less than a competitive employment level.

17 The provisions of this section shall be in effect only from July 1, ~~2019~~
18 2020 through June 30, ~~2020~~ 2021.

19
20 SECTION 13. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
22 DEVELOPMENTAL DISABILITIES - TIMBER SALES PROCEEDS - CAPITAL IMPROVEMENTS AND
23 EQUIPMENT. The Division of Developmental Disabilities Services is authorized
24 to use the administrative operating accounts for capital improvements to
25 physical plants and for the purchase of capital equipment. The funds shall be
26 held by the Department of Human Services - Division of Developmental
27 Disabilities Services from the proceeds of the sale of timber that may be
28 harvested from land owned by the Division of Developmental Disabilities
29 Services. All funds deposited and all expenses shall be tracked separately.
30 The harvesting of timber is specifically authorized to provide funds to
31 finance capital improvements to the physical plants and for the purchase of
32 major capital equipment.

33 The Division of Developmental Disabilities Services shall report all
34 income derived from timber management to the Chief Fiscal Officer of the
35 State and the Arkansas Legislative Council or Joint Budget Committee. Any
36 contracts initiated for the harvesting of timber shall be submitted to the

1 Review Subcommittee of the Arkansas Legislative Council or Joint Budget
2 Committee for prior review. All expenditures of funds derived from the sale
3 of timber will be expended in accordance with relevant state purchasing laws.

4 The provisions of this section shall be in effect only from July 1, ~~2019~~
5 2020 through June 30, ~~2020~~ 2021.

6
7 SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. HUMAN
9 DEVELOPMENT CENTERS AND COMMUNITY PROVIDERS.

10 (A) The Developmental Disabilities Services Board or the Department of
11 Human Services shall not close any of the state administered Human
12 Development Centers which are located at Conway, Arkadelphia, Jonesboro,
13 Booneville, and Warren.

14 (B) The Department of Human Services shall continue to accept clients for
15 whom it has determined that therapy and residential services are needed at
16 state administered Human Development Centers and Community Programs licensed
17 by DDS shall continue to accept clients for whom it has been determined in
18 accordance with federal law that are in need of services in the community.

19 (C) Except for use as federal matching funds, no funds for community based
20 services licensed by DDS shall be transferred from Grants to Community
21 Providers line item of the Developmental Disabilities Services - Grants-in-
22 Aid appropriation unless the transfer(s) directly benefit(s) community based
23 services for persons with developmental disabilities or from the
24 appropriation for the Human Development Centers unless the transfer(s)
25 directly benefit(s) the Human Development Centers.

26 (D) Nor shall any general revenue funding as of July 1, ~~2019~~ 2020 from the
27 Grants to Community Providers line item of the Developmental Disabilities
28 Services - Grants-in-Aid appropriation for persons with developmental
29 disabilities or from any other general revenues as of July 1, ~~2019~~ 2020,
30 applied as federal matching funds for community based services licensed by
31 DDS on July 1, ~~2019~~ 2020 be reduced below the approved funding level on July
32 1, ~~2019~~ 2020; nor shall the general revenues applied as federal matching
33 funds for the Human Development Centers be reduced below the approved funding
34 level on July 1, ~~2019~~ 2020.

35 The provisions of this section shall be in effect only from July 1, ~~2019~~
36 2020 through June 30, ~~2020~~ 2021.

1
2 SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

4 ELIMINATION OF AUTISM WAIVER SERVICES WAITING LIST. Immediately upon the
5 effective date of this Act, the Department of Human Services - Division of
6 Developmental Disabilities Services shall budget, allocate, and expend up to
7 one million dollars (\$1,000,000) for the elimination of the Autism Waiver
8 Services Program waiting list.

9 The provisions of this section shall be in effect only from July 1,
10 ~~2019~~ 2020 through June 30, ~~2020~~ 2021.

11
12 SECTION 16. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
13 authorized by this act shall be limited to the appropriation for such agency
14 and funds made available by law for the support of such appropriations; and
15 the restrictions of the State Procurement Law, the General Accounting and
16 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
17 Procedures and Restrictions Act, or their successors, and other fiscal
18 control laws of this State, where applicable, and regulations promulgated by
19 the Department of Finance and Administration, as authorized by law, shall be
20 strictly complied with in disbursement of said funds.

21
22 SECTION 17. LEGISLATIVE INTENT. It is the intent of the General
23 Assembly that any funds disbursed under the authority of the appropriations
24 contained in this act shall be in compliance with the stated reasons for
25 which this act was adopted, as evidenced by the Agency Requests, Executive
26 Recommendations and Legislative Recommendations contained in the budget
27 manuals prepared by the Department of Finance and Administration, letters, or
28 summarized oral testimony in the official minutes of the Arkansas Legislative
29 Council or Joint Budget Committee which relate to its passage and adoption.

30
31 SECTION 18. EMERGENCY CLAUSE. It is found and determined by the
32 General Assembly, that the Constitution of the State of Arkansas prohibits
33 the appropriation of funds for more than a one (1) year period; that the
34 effectiveness of this Act on July 1, 2020 is essential to the operation of
35 the agency for which the appropriations in this Act are provided, and that in
36 the event of an extension of the legislative session, the delay in the

effective date of this Act beyond July 1, 2020 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2020.
