21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code Title 16, Chapter 34, is amended to add an
24 additional section to read as follows:

25 16-34-107. Donation of per diem compensation and mileage
26 reimbursement.

27 (a) A person eligible to receive per diem compensation or mileage
28 reimbursement, or both, under this chapter may donate the per diem
29 compensation or mileage reimbursement, or both, that he or she receives to an
30 eligible statewide nonprofit entity.

31 (b)(1)(A) The Administrative Office of the Courts shall compile a list
32 of five (5) statewide eligible nonprofit entities to which a person receiving
33 per diem compensation or mileage reimbursement, or both, under this chapter
34 may make his or her donation under this section.

35 (B) In compiling the list of statewide eligible nonprofit
36 entities described under subdivision (b)(1)(A) of this section, the office



1 shall consult with the Supreme Court and the Judicial Council, Inc., to
2 determine the eligible statewide nonprofit entities under this section.

3 (2) An eligible nonprofit entity should offer services in
4 multiple counties and have as one (1) of its primary goals the providing of:

5 (A) Crime victim assistance or counseling;

6 (B) Services for abused or neglected children;

7 (C) Shelter for victims of domestic violence;

8 (D) Services for veterans; or

9 (E) Legal education for students seeking a Juris Doctor
10 degree.

11 (c) The office shall offer guidance on procedures for making,
12 collecting, and distributing donations under this section.

14 *SECTION 2. EFFECTIVE DATE.*

15 *This act is effective on and after January 1, 2022.*
