22 SECTION 21. LEGISLATIVE INTENT. It is the intent of the General 23 Assembly that any funds disbursed under the authority of the appropriations 24 contained in this act shall be in compliance with the stated reasons for 25 which this act was adopted, as evidenced by the Agency Requests, Executive 26 Recommendations and Legislative Recommendations contained in the budget 27 manuals prepared by the Department of Finance and Administration, letters, or 28 summarized oral testimony in the official minutes of the Arkansas Legislative 29 Council or Joint Budget Committee which relate to its passage and adoption. 30

31 SECTION 22. EMERGENCY CLAUSE. It is found and determined by the 32 General Assembly, that the Constitution of the State of Arkansas prohibits 33 the appropriation of funds for more than a one (1) year period; that the 34 effectiveness of this Act on July 1, 2021 is essential to the operation of 35 the agency for which the appropriations in this Act are provided, and that in 36 the event of an extension of the legislative session, the delay in the

1	effective date of this Act beyond July 1, 2021 could work irreparable harm
2	upon the proper administration and provision of essential governmental
3	programs. Therefore, an emergency is hereby declared to exist and this Act
4	being necessary for the immediate preservation of the public peace, health
