22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. REGULAR SALARIES. There is hereby established for the State
25 Department for Social Security Administration Disability Determination for
26 the 2021-2022 fiscal year, the following maximum number of regular employees.

36 SECTION 2. EXTRA HELP. There is hereby authorized, for the State

1 Department for Social Security Administration Disability Determination for
 2 the 2021-2022 fiscal year, the following maximum number of part-time or
 3 temporary employees, to be known as "Extra Help", payable from funds
 4 appropriated herein for such purposes: twenty (20) temporary or part-time
 5 employees, when needed, at rates of pay not to exceed those provided in the
 6 Uniform Classification and Compensation Act, or its successor, or this act
 7 for the appropriate classification.

8
 9 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 10 to the State Department for Social Security Administration Disability
 11 Determination, to be payable from the federal funds as designated by the
 12 Chief Fiscal Officer of the State, for personal services and operating
 13 expenses of the State Department for Social Security Administration
 14 Disability Determination for the fiscal year ending June 30, 2022, the
 15 following:

 31 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA
 33 HELP RESTRICTION. No extra help employee of Disability Determination for
 34 Social Security Administration shall be employed for a period of time to
 35 exceed eighteen hundred (1800) hours in any single fiscal year.

36 The provisions of this section shall be in effect only from July 1, ~~2020~~

1 2021 through June 30, ~~2021~~ 2022.

3 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW.
5 ADDITIONAL POSITIONS. The Director of the State Department for Social
6 Security Administration Disability Determination, after receiving the
7 approval of the Office of Personnel Management, and after seeking prior
8 review by the Arkansas Legislative Council or Joint Budget Committee, shall
9 have the authority to establish such new additional full time positions as
10 may become necessary to carry out the objectives of the department and/or to
11 meet Federal requirements of new and/or expanded programs where such needs
12 are financed by Federal funds; provided that not more than two hundred fifty
13 (250) positions may be created in addition to those authorized in the Regular
14 Salaries section of this Act.

15 If the department requests continuation of any positions as established
16 herein, the positions must be requested as new positions in the department's
17 budget request.

18 The provisions of this section shall be in effect only from July 1,
19 2021 through June 30, 2022.

20
21 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
22 authorized by this act shall be limited to the appropriation for such agency
23 and funds made available by law for the support of such appropriations; and
24 the restrictions of the State Procurement Law, the General Accounting and
25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
26 Procedures and Restrictions Act, or their successors, and other fiscal
27 control laws of this State, where applicable, and regulations promulgated by
28 the Department of Finance and Administration, as authorized by law, shall be
29 strictly complied with in disbursement of said funds.

30
31 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
32 Assembly that any funds disbursed under the authority of the appropriations
33 contained in this act shall be in compliance with the stated reasons for
34 which this act was adopted, as evidenced by the Agency Requests, Executive
35 Recommendations and Legislative Recommendations contained in the budget
36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
5 Assembly, that the Constitution of the State of Arkansas prohibits the
6 appropriation of funds for more than a one (1) year period; that the
7 effectiveness of this Act on July 1, 2021 is essential to the operation of
8 the agency for which the appropriations in this Act are provided, and that in
9 the event of an extension of the legislative session, the delay in the
10 effective date of this Act beyond July 1, 2021 could work irreparable harm
11 upon the proper administration and provision of essential governmental
12 programs. Therefore, an emergency is hereby declared to exist and this Act
13 being necessary for the immediate preservation of the public peace, health
14 and safety shall be in full force and effect from and after July 1, 2021.
