26	SECTION 1. Arkansas Code Title 20, Chapter 78, Subchapter 2, is		
27	amended to add an additional section to read as follows:		
28	20-78-229. Sex offender prohibited from being on childcare facility		
29	<pre>premises - Notice concerning registered sex offenders.</pre>		
30	(a) A person who is convicted of a sex offense against a minor or		
31	required to register as a sex offender under the Sex Offender Registration	:	
32	Act of 1997, § 12-12-901 et seq., shall not be permitted on the premises of a		
33	childcare facility:		
34	(1) For a purpose other than to bring his or her child to the	,	
35	childcare facility or to collect his or her child from the childcare facil	<u>ity</u>	
36	when another child or other children are on the premises of the childcare		

1	<u>facility; or</u>
2	(2) In a manner that violates the Division of Child Care and
3	Early Childhood Education's rules concerning childcare facilities.
4	(b)(1) An owner, operator, service provider, or director of a
5	childcare facility shall provide written notification that a registered sex
6	offender is, has been, or will be on or near the premises of the childcare
7	facility to the parent, legal guardian, person having lawful control, or
8	person standing in loco parentis of a child who attends the childcare
9	facility if the owner, operator, service provider, or director of the
10	childcare facility becomes aware that a person who is convicted of a sex
11	offense against a minor or is required to register as a sex offender under
12	the Sex Offender Registration Act of 1997, § 12-12-901 et seq.:
13	(A) Resides in or near the premises of the childcare
14	facility in violation of § 5-14-128; or
15	(B) Is, has been, or will be present on the premises of
16	the childcare facility for a purpose other than to bring his or her child to
17	the childcare facility or to collect his or her child from the childcare
18	<u>facility.</u>
19	(2) Notice under subdivision (b)(1) of this section is not
20	required if a person who is convicted of a sex offense against a minor or is
21	required to register as a sex offender under the Sex Offender Registration
22	Act of 1997, § 12-12-901 et seq.:
23	(A) Is, has been, or will be present on the premises of
24	the childcare facility to bring his or her child to the childcare facility or
25	to collect his or her child from the childcare facility; or
26	(B) Is attending an event or a function in which his or
27	her child is participating at the childcare facility.
28	(c) This section does not prohibit a person who is convicted of a sex
29	offense against a minor or required to register as a sex offender under the
30	Sex Offender Registration Act of 1997, § 12-12-901 et seq., from attending:
31	(1) A church service or function at a church in which a
32	childcare facility is located if the church service or function is not held
33	on the premises of the childcare facility; or
34	(2) An event or a function in which his or her child is
35	participating at the childcare facility.
