24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Arkansas Code Title 20, Chapter 78, Subchapter 2, is
27	amended to add an additional section to read as follows:
28	20-78-229. Notice concerning registered sex offenders — Definition.
29	(a) As used in this section, "immediate family member" means a person
30	who resides in the home of and is the spouse, parent, child, brother, sister,
31	mother-in-law, father-in-law, son-in-law, daughter-in-law, brother-in-law, or
32	sister-in-law of an owner, operator, service provider, or director of a
33	childcare facility or an employee of a childcare facility.
34	(b) If an owner, operator, service provider, or director of a
35	childcare facility or an employee of a childcare facility has an immediate
36	family member who is a Level 2 sex offender whose information is made public

1	under § 12-12-913(j)(1)(B), a Level 3 sex offender, or a Level 4 sex
2	offender, the owner, operator, service provider, or director of the childcare
3	facility shall provide notification in writing or by electronic mail to the
4	parent, legal guardian, person having lawful control, or person standing in
5	loco parentis of a child who attends the childcare facility that:
6	(1) The owner, operator, service provider, director, or employee
7	has an immediate family member who is a Level 2, Level 3, or Level 4 sex
8	offender; and
9	(2) The immediate family member who is a Level 2, Level 3, or
10	Level 4 sex offender will not be present on the premises of the childcare
11	facility while children are present.
12	(c) This section does not create a duty on behalf of an owner,
13	operator, service provider, or director of a childcare facility to take any
14	action other than providing the notice required under subsection (b) of this
15	section if the owner, operator, service provider, or director of the
16	childcare facility becomes aware of the information concerning a sex offender
17	described in subsection (b) of this section.
