9 INTRASTATE METRO PLANNING GRANTS. As referenced in Section 9 of Act 637 of
10 1995, the authorized funding for Intrastate Metro Planning Grants that are
11 evenly distributed among planning and development districts under the
12 Miscellaneous Grants and Expenses Section of this Act shall include the West
13 Central Arkansas Economic Development District.

14 The provisions of this section shall be in effect only from July 1, ~~2020~~
15 2021 through June 30, ~~2021~~ 2022.

16
17 SECTION 71. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
19 USAGE AUTHORIZED. The Arkansas Children's Hospital President and C.E.O. may
20 request the Department of Human Services-Division of Medical Services to
21 retain in the Department of Human Services Grant Fund account an amount not
22 to exceed \$1,000,000 for funds made available by the act to be used to match
23 federal funds used for supplemental Medicaid payments to Arkansas Children's
24 Hospital.

25 The provisions of this section shall be in effect only from July 1, ~~2020~~
26 2021 through June 30, ~~2021~~ 2022.

28 SECTION 72. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
29 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
30 PROCEDURES - MEDICAL MARIJUANA IMPLEMENTATION AND REGULATION. In the event
31 that sufficient appropriation is not provided by the General Assembly for
32 expenditures resulting from the implementation and regulation of the Arkansas
33 Medical Marijuana Amendment of 2016 for any state agency, pursuant to
34 Arkansas Code § 19-4-701 et seq., said agency shall request a transfer of
35 appropriation from the Chief Fiscal Officer of the State, stating clearly the
36 amount required. Upon approval of the Chief Fiscal Officer of the State said

1 appropriations shall be established upon the books of the Department of
2 Finance and Administration in compliance with the applicable classifications
3 of appropriations as enumerated in Arkansas Code §§ 19-4-521 through 19-4-
4 527.

5 The provisions of this section shall be in effect only from July 1, ~~2020~~
6 2021 through June 30, ~~2021~~ 2022.

7
8 SECTION 73. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
10 TRANSFER AUTHORITY. From time to time, the Chief Fiscal Officer of the State
11 may transfer from his or her books and those of the Treasurer of State and
12 the Auditor of State from the Medical Marijuana Implementation and Operations
13 Fund to various state agencies' funds the amounts necessary to fund the
14 expenses for the implementation, administration, and/or enforcement of the
15 Arkansas Medical Marijuana Amendment of 2016.

16 The provisions of this section shall be in effect only from July 1, ~~2020~~
17 2021 through June 30, ~~2021~~ 2022.

19 SECTION 74. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BLANKET
21 BOND PROGRAM. The ~~Director~~ Secretary of the Department of Finance and
22 Administration is authorized to transfer Appropriation between the Blanket
23 Surety Bond Program appropriations authorized for State Employees
24 (Appropriation 2DM), County Employees (Appropriation 2DN), Municipal
25 Employees (Appropriation 2DP) and Public School Employees (Appropriation
26 2DQ).

27 The provisions of this section shall be in effect only from July 1, ~~2020~~
28 2021 through June 30, ~~2021~~ 2022.

30 SECTION 75. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
32 PROCEDURES - VARIOUS TEMPORARY APPROPRIATION FOR STATE AGENCIES AND
33 INSTITUTIONS. (i) In the event that sufficient appropriation is not provided
34 by the General Assembly for any state agency or institution, an agency or
35 institution may request a transfer of appropriation, as provided in the
36 Various Temporary Appropriation for State Agencies and Institutions

1 Appropriation Section of this Act, from the Chief Fiscal Officer of the
2 State, stating clearly the amount requested, purpose and any additional
3 information requested by the Chief Fiscal Officer of the State.

4 (ii) After reviewing a request the Chief Fiscal Officer of the State may
5 deny, modify or approve the agencies or institutions request based on the
6 estimated amount of appropriation needed and currently available, purpose,
7 estimated funding available and preferred spending priority. Upon approval
8 or modification of a request by the Chief Fiscal Officer of the State and
9 after meeting the requirements of subsection (iii) herein, the Department of
10 Finance and Administration shall establish the transfer of appropriation on
11 the books of the Department of Finance and Administration and the State
12 Auditor, in compliance with the applicable classifications of appropriations
13 as enumerated in Arkansas Code 19-4-521 through 19-4-525.

14 (iii) Any request approved as authorized in subsection (ii) herein,
15 including requests that establish a new commitment item or new appropriation
16 shall require prior approval by the Arkansas Legislative Council or if
17 meeting in Regular or Fiscal Session the Joint Budget Committee.

18 (iv) Any appropriation approved as authorized in this Section shall not be
19 carried forward to the next fiscal year and shall be identified as a change
20 level increase by the state agency or institution, if requested.

21 (v) Determining the maximum amount of appropriation for a state agency or
22 institution each fiscal year is the prerogative of the General Assembly.
23 This is usually accomplished by delineating such maximums in the
24 appropriation act(s) for a state agency or institution. Further, the General
25 Assembly has determined that a state agency or institution may operate more
26 efficiently if some flexibility is provided to the state agency or
27 institution authorizing broad powers under this section. Therefore, it is
28 both necessary and appropriate that the General Assembly maintain oversight
29 by requiring prior approval of the Legislative Council or Joint Budget
30 Committee as provided by this section. The requirement of approval by the
31 Legislative Council or Joint Budget Committee is not a severable part of this
32 section. If the requirement or approval by the Legislative Council or Joint
33 Budget Committee is ruled unconstitutional by a court of competent
34 jurisdiction, this entire section is void.

2 SECTION 76. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
3 authorized by this act shall be limited to the appropriation for such agency
4 and funds made available by law for the support of such appropriations; and
5 the restrictions of the State Procurement Law, the General Accounting and
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
7 Procedures and Restrictions Act, or their successors, and other fiscal
8 control laws of this State, where applicable, and regulations promulgated by
9 the Department of Finance and Administration, as authorized by law, shall be
10 strictly complied with in disbursement of said funds.

12 SECTION 77. LEGISLATIVE INTENT. It is the intent of the General
13 Assembly that any funds disbursed under the authority of the appropriations
14 contained in this act shall be in compliance with the stated reasons for
15 which this act was adopted, as evidenced by the Agency Requests, Executive
16 Recommendations and Legislative Recommendations contained in the budget
17 manuals prepared by the Department of Finance and Administration, letters, or
18 summarized oral testimony in the official minutes of the Arkansas Legislative
19 Council or Joint Budget Committee which relate to its passage and adoption.

20
21 SECTION 78. EMERGENCY CLAUSE. It is found and determined by the
22 General Assembly, that the Constitution of the State of Arkansas prohibits
23 the appropriation of funds for more than a one (1) year period; that the
24 effectiveness of this Act on July 1, 2021 is essential to the operation of
25 the agency for which the appropriations in this Act are provided, and that in
26 the event of an extension of the legislative session, the delay in the
27 effective date of this Act beyond July 1, 2021 could work irreparable harm
28 upon the proper administration and provision of essential governmental
29 programs. Therefore, an emergency is hereby declared to exist and this Act
30 being necessary for the immediate preservation of the public peace, health
31 and safety shall be in full force and effect from and after July 1, 2021.
