25	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27	SECTION 1. Arkansas Code § 6-11-102(c)(1), concerning the
28	qualifications of the Commissioner of Elementary and Secondary Education, is
29	amended to read as follows:
30	(c)(l) The person selected as the commissioner shall:
31	(A) Be a person of good moral character, recognized as a
32	leader in the field of education, and qualified technically and by experience
33	to direct the work of the division; and
34	(B) Unless a deputy commissioner meets the requirements of
35	this subdivision (c)(l)(B), a person selected as commissioner shall:
36	(i) Hold a master's degree from an accredited

1	institution;
2	(ii)<u>(</u>C) Have had ten (10) years' experience as a
3	teacher, five (5) of which must be of an administrative or supervisory
4	nature; and
5	(iii)(D) Hold a valid state teacher's license.

7	SECTION 2. Arkansas Code § 6-11-102, concerning the Commissioner of
8	Elementary and Secondary Education, is amended to add an additional
9	subsection to read as follows:
10	(g)(1) The person selected as the secretary shall:
11	(A) Be a person of good moral character, recognized as a
12	leader in the field of education, and qualified technically and by experience
13	to direct the work of the division; and
14	(B) Unless the commissioner and a deputy commissioner meet
15	the requirements under this subdivision (g)(l)(B), a person selected as
16	secretary shall:
17	(i) Hold a master's degree from an accredited
18	institution;
19	<u>(ii) Have had ten (10) years' experience as a</u>
20	teacher, five (5) years of which must be of an administrative or supervisory
21	nature; and
22	(iii) Hold a valid state teacher's license.
23	(2) No person who is related within the fourth degree of consanguinity
24	or affinity to any member of the state board shall be eligible to serve as
25	secretary.

27	SECTION 3. EFFECTIVE DATE. Sections 1 and 2 of this act shall be
28	effective on and after July 1, 2023.
