32	SECTION 1. Arkansas Code Title 6, Chapter 16, Subchapter 1,	is amended

35	(a) As used in this section, "public school" includes:

10	(B) Gender;
11	(C) Political affiliation;
12	(D) Social class; or
13	(E) Particular class of people;
14	(3) Is designed primarily for students of a particular ethnic
15	group;
16	(4) Advocates the solidarity of, or the isolation of, a group of
17	students instead of treatment of students as individuals based on a
18	particular characteristic, including without limitation:
19	(A) Ethnicity;
20	(B) Race;
21	(C) Religion;
22	(D) Gender; and

24	(5) Violates state or federal civil rights laws; or
25	(6) Negatively targets specific nationalities or countries.
26	(c)(l) If the State Board of Education determines that a public school
27	district or open-enrollment public charter school has violated subsection (b)
28	of this section, the state board shall notify the public school district or
29	open-enrollment public charter school of its violation.
30	(2)(A) If a public school district or open-enrollment public
31	charter school fails to comply with subsection (b) of this section within
32	sixty (60) days of notification of its failure to comply under subdivision
