36           SECTION 53. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS



1 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
2 PROFESSIONAL BAIL BONDS COMPANY AND PROFESSIONAL BAIL BONDSMAN LICENSING  
3 BOARD - FUND TRANSFER. The Professional Bail Bonds Company and Professional  
4 Bail Bondsman Licensing Board shall deposit as special revenues sufficient  
5 fees and penalties directly into the Bail Bondsman Board fund to provide for  
6 personal services and operating expenses for the board. At the end of each  
7 fiscal year, the Professional Bail Bondsman Licensing Board shall be allowed  
8 to retain a fund balance sufficient to cover the personal services and  
9 operating expenses of the board for the following fiscal year. Seventy-five  
10 percent (75%) of any funds remaining in excess of this balance shall be  
11 transferred to the General Revenue Fund Account in the State Treasury.

17 BOARD OF BARBER EXAMINERS - APPLICANT PROXIMITY TO EXISTING BARBER COLLEGES.  
18 Notwithstanding any other provisions under Arkansas Law, the State Board of  
19 Barber Examiners shall not deny any application for the establishment of a  
20 new barber college on the basis of geographic proximity to an existing barber  
21 college.

25 SECTION 55. COMPLIANCE WITH OTHER LAWS. Disbursement of funds

8 SECTION 57. EMERGENCY CLAUSE. It is found and determined by the

11 effectiveness of this Act on July 1, 2021 is essential to the operation of  
12 the agency for which the appropriations in this Act are provided, and that in  
13 the event of an extension of the legislative session, the delay in the  
14 effective date of this Act beyond July 1, 2021 could work irreparable harm  
15 upon the proper administration and provision of essential governmental  
16 programs. Therefore, an emergency is hereby declared to exist and this Act  
17 being necessary for the immediate preservation of the public peace, health  
18 and safety shall be in full force and effect from and after July 1, 2021.
