SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 10 11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 12 ALLOWANCES. The Board of Trustees of Arkansas Tech University may make 13 special allowances available to any coach who coaches more than one sport in 14 an amount not to exceed \$10,000 per fiscal year for any one coach. Further,

15 if the special allowance funds authorized herein are utilized, Arkansas Tech

16 University shall report annually to the Legislative Joint Auditing Committee 17

the exact disposition of those special allowance funds.

18 The provisions of this section shall be in effect only from July 1, 2020 19 2021 through June 30, <del>2021</del> 2022.

21 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS 23 TECH INSTITUTE. The Arkansas Tech Institute (ATI) shall be administered 24 under the direction of Arkansas Tech University. Utilizing a 25 multidisciplinary collaboration of professionals, ATI shall explore, develop, 26 implement, and evaluate new and better ways to integrate the teaching, study 27 and performance of business, engineering, emergency management, agriculture, 28 healthcare, technical programs and computer sciences for academic, economic, 29 and economic development purposes in Arkansas. ATI priorities shall include, 30 but are not limited to, economic development, technology development, and

31 "cyber-park" development. Arkansas Tech University shall make annual reports

32 to the Arkansas Legislative Council on all matters of funding, existing

33 programs, and services offered through ATI.

34 The provisions of this section shall be in effect only from July 1, 2020 35 2021 through June 30, <del>2021</del> 2022.

1	SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2	CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TUITION
3	REIMBURSEMENT. The Board of Trustees of Arkansas Tech University shall be
4	authorized to reimburse tuition, fees, and other educational related expenses
5	of current faculty who seek additional education levels that will benefit the
6	university in meeting accreditation and professional standards. Reimbursement
7	shall be authorized only when the reimbursement request has been documented
8	by the institution to meet critical shortage instructional areas or is
9	necessary for restructuring of the academic programs of the institution.
10	The provisions of this section shall be in effect only from July 1, 2021
11	through June 30, 2022.
12	
13	SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
14	authorized by this act shall be limited to the appropriation for such agency
15	and funds made available by law for the support of such appropriations; and
16	the restrictions of the State Procurement Law, the General Accounting and
17	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
18	Procedures and Restrictions Act, the Higher Education Expenditures
19	Restrictions Act, or their successors, and other fiscal control laws of this
20	State, where applicable, and regulations promulgated by the Department of
21	Finance and Administration, as authorized by law, shall be strictly complied
22	with in disbursement of said funds.

24	SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
25	Assembly that any funds disbursed under the authority of the appropriations
26	contained in this act shall be in compliance with the stated reasons for
27	which this act was adopted, as evidenced by the Agency Requests, Executive
28	Recommendations and Legislative Recommendations contained in the budget
29	manuals prepared by the Department of Finance and Administration, letters, or
30	summarized oral testimony in the official minutes of the Arkansas Legislative
31	Council or Joint Budget Committee which relate to its passage and adoption.
32	
33	SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
34	General Assembly, that the Constitution of the State of Arkansas prohibits
35	the appropriation of funds for more than a one (1) year period; that the

effectiveness of this Act on July 1, 2021 is essential to the operation of

1	the agency for which the appropriations in this Act are provided, and that in
2	the event of an extension of the legislative session, the delay in the
3	effective date of this Act beyond July 1, 2021 could work irreparable harm
4	upon the proper administration and provision of essential governmental
5	programs. Therefore, an emergency is hereby declared to exist and this Act
6	being necessary for the immediate preservation of the public peace, health
7	and safety shall be in full force and effect from and after July 1, 2021.
