25	SECTION 1. DO N	NOT CODIFY. <u>Title.</u>	
26	This act shall b	oe known and may be cited as the "	'Marshallese Law
27	Enforcement Act".

29	SECTION 2. Arka	ansas Code § 12-8-202(a), concerni	ing the qualifications
30	to be a police officer	of the Division of Arkansas Stat	ce Police, is amended
31	to read as follows:		
32	(a)(1)(A) All a	applicants for positions as police	e officers of the
33	Department Division of	Arkansas State Police shall be o	citizens of the United
34	States or nonimmigrants legally admitted to the United States under a Compact		
35	of Free Association.		
36	(B)	However, the applicants must bec	come citizens of the

1	State of Arkansas in order to commence employment.
2	(2) Any applicant shall be employed strictly upon an efficiency
3	basis irrespective of race, gender, religion, or political affiliation.
4	
5	SECTION 3. Arkansas Code Title 12, Chapter 9, Subchapter 1, is amended
6	to add an additional section to read as follows:
7	12-9-124. Certified officer required to be citizen or nonimmigrant
8	legally admitted to the United States under Compact of Free Association.
9	A person is ineligible to be a certified law enforcement officer if the
10	<pre>person is not:</pre>
11	(1) A citizen of the United States; or
12	(2) A nonimmigrant legally admitted to the United States under a
13	Compact of Free Association entered into on or before January 1, 2021.
14	
15	SECTION 4. Arkansas Code § 12-9-304(j), concerning the qualifications
16	to become an auxiliary law enforcement officer, is amended to read as
17	follows:
18	(j) Every person appointed or serving as an auxiliary law enforcement
19	officer shall be a citizen of the United States and shall be at least twenty-
20	one (21) years of age.
