3	SECTION 2. Arkansas Code § 24-6-502 is amended to read as follows:
4	24-6-502. Election to participate in Arkansas State Police Officers'
5	Tier Two Deferred Retirement Option Plan.
6	In lieu of terminating employment and accepting a service retirement
7	pension, a state police officer may elect to participate in the Arkansas
8	State Police Officers' Tier Two Deferred Retirement Option Plan and defer the
9	receipt of benefits in accordance with this subchapter if:
10	(1) The state police officer:
11	(A) Is a member of the State Police Retirement System's
12	Tier Two Benefit Plan under § 24-6-401 et seq.;
13	(B) Has at least thirty (30) twenty-eight (28) years of
14	actual service as a member of the State Police Retirement System's Tier Two
15	Benefit Plan under § 24-6-401 et seq.; and
16	(C) Is eligible to receive a service retirement pension;
17	and
18	(2) The Board of Trustees of the State Police Retirement System
19	approves the participation in the Arkansas State Police Officers' Tier Two
20	Deferred Retirement Option Plan.
