2	(B) The redetermined amount of the monthly benefit to be
3	paid to the person shall not be less than the redetermined amount of the
4	monthly benefit paid to the person in the preceding year.
5	
6	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
7	General Assembly of the State of Arkansas that provisions of the law
8	concerning the Arkansas Public Employees' Retirement System, a state agency
9	created by the General Assembly for the purpose of providing retirement
10	benefits to public employees of this state, are in need of revision and
11	updating to maintain the retirement laws in conformance with sound public
12	pension policy; that the system operates on a fiscal year of July 1 to June
13	30; that having a July 1, 2021, effective date is necessary to allow the
14	provisions of this act to begin on the first day of the fiscal year to
15	provide for the proper administration of the procedures mandated by this act;
16	that the revisions and updates to the law are of great importance for
17	actuarial purposes and to protect member benefits provided by the system; and
18	that this act is immediately necessary in order to maintain an orderly system
19	of benefits for the members of the system. Therefore, an emergency is
20	declared to exist, and this act being necessary for the preservation of the
21	public peace, health, and safety shall become effective on July 1, 2021.
