12	otherwise payable as of the immediately preceding July 1 increased by the		
13	lesser of three percent (3%) or the percentage change in the Consumer Price		
14	Index for Urban Wage Earners and Clerical Workers as determined by the United		
15	States Department of Labor over the one-year period ending in the December		
16	immediately preceding the date for which the redetermined amount is being		
17	calculated.
