17	certificate of title upon the death of the owner or upon the death of all		
18	joint owners to the beneficiary named on the face of the certificate of title		
19	with beneficiary.		
20	(c)(l) The owner of a vehicle or watercraft may submit a transfer on		
21	death application to the office to request the issuance of a certificate of		
22	title with beneficiary or a change to a certificate of title with		
23	beneficiary.		
24	(2) The owner shall provide the following information in the

26	(A) Whether the applicant seeks to add, remove, or change		
27	a beneficiary;		
28	(B) The full legal name of the beneficiary;

- 12 (C) The certificate of title with beneficiary processing
- 13 fee of ten dollars (\$10.00).
- 14 (4)(A) The fee remitted under subdivision (c)(3)(C) of this
- 15 section shall be deposited into the State Central Services Fund for the
- 16 benefit of the Revenue Division of the Department of Finance and
- 17 Administration.
- 18 (B) The fee shall be credited as supplemental and in
- 19 addition to all other funds as may be deposited for the benefit of the

- 21 (C) The fee shall not be considered or credited to the

- 23 (d)(1) The office shall not issue a certificate of title with
- 24 beneficiary to an owner of a vehicle or watercraft if:
- 25 (A) The vehicle <u>or watercraft</u> is encumbered by a lien; or
- 26 (B) The owner holds his or her interest in the vehicle or
- 27 watercraft as a tenant in common with another person.
- 28 (2) If a lien request is made for a certificate of title with
- 29 beneficiary, the beneficiary shall be removed and the lien added.
- 30 (e) The certificate of title with beneficiary issued by the office
- 31 shall include after the name of the owner the words "transfer on death to" or
- 32 the abbreviation "TOD" followed by the name of the beneficiary.
- 33 (f) During the lifetime of the sole owner or before the death of the
- 34 last surviving joint owner:
- 35 (1) The signature or consent of the beneficiary is not required
- 36 for any transaction relating to the vehicle or watercraft for which a

- 2 (2) The certificate of title with beneficiary is revoked by:
- 3 (A) Selling the vehicle <u>or watercraft</u> with proper
- 4 assignment and delivery of the certificate of title to another person; or
- 5 (B) Filing an application with the office to remove or
- 6 change a beneficiary as provided under subsection (c) of this section.
- 7 (g) Except as provided in subsection (f) of this section, the
- 8 designation of the beneficiary in a certificate of title with beneficiary
- 9 shall not be changed or revoked:
- 10 (1) By will or any other instrument;
- 11 (2) Because of a change in circumstances; or
- 12 (3) In any other manner.
- 13 (h) The interest of the beneficiary in a vehicle or watercraft on the
- 14 death of the sole owner or on the death of the last surviving joint owner is
- 15 subject to any contract of sale, assignment, or security interest to which
- 16 the owner of the vehicle <u>or watercraft</u> was subject during his or her
- 17 lifetime.
- 18 (i)(1)(A) Upon the death of the owner, the office shall issue a new
- 19 certificate of title for the vehicle or watercraft to the surviving owner or,
- 20 if no surviving owner, to the beneficiary if the surviving owner or
- 21 beneficiary presents the following:
- 22 (i) Proof of death of the owner that includes a
- 23 death certificate issued by the state or a political subdivision of the
- 24 state;
- 25 (ii) Surrender of the outstanding certificate of
- 26 title with beneficiary; and
- 27 (iii) Application and payment of the title
- 28 application fee and title fee.
- 29 (B) A certificate of title issued under this subsection
- 30 will be subject to any existing security interest.
- 31 (2) If the surviving owner or beneficiary chooses, he or she can
- 32 submit a completed certificate of title with beneficiary application as
- 33 provided under this section, along with the ten dollar (\$10.00) processing
- 34 fee, at the time of the application for a new title under this subsection.
- 35 (3) The transfer under this subsection is a transfer by
- 36 operation of law, and § 27-14-907 applies to the extent practicable and not

7	(1)(1) The office may promulgate rules for the administration of this		
8	section.		
9	(2) If rules are promulgated, the office shall consult with the		
10	Arkansas State Game and Fish Commission about the rules.
