## For An Act To Be Entitled

AN ACT TO AMEND THE LAW CONCERNING THE LIMITATIONS ON THE ISSUANCE OF MILITARY AND VETERANS SPECIAL LICENSE PLATES; TO AUTHORIZE THE ISSUANCE OF ADDITIONAL SPECIAL LICENSE PLATES IN CERTAIN CIRCUMSTANCES; AND FOR OTHER PURPOSES.

## Subtitle

TO AMEND THE LAW CONCERNING THE LIMITATIONS ON THE ISSUANCE OF MILITARY and veterans special license plates; and TO AUTHORIZE THE ISSUANCE OF ADDITIONAL special license plates in certain CIRCUMSTANCES.
be it enacted by the general assembly of the state of arkansas:

SECTION 1. Arkansas Code § 27-24-206 is amended to read as follows: 27-24-206. Fees and limitations.
(a)(1) Except as provided in subdivisions (a)(2) and (b)(2)(B) of this section and in § 27-24-213, special license plates created and issued under this subchapter shall be free of charge to an eligible applicant.
(2) To defray the cost of the issuance and renewal of the first special license plate under this subchapter, the Secretary of the Department of Finance and Administration may charge an annual fee for renewal not to exceed one dollar (\$1.00).
(b) (1) Except as provided in subsections (c) and (e) of this section,
a A person who is eligible to receive a special license plate under this chapter shall be limited to two (2) three (3) additional special license plates under this subchapter.
(2) Except as provided in subsection (c) of this section, a second special license plate under this section shall be issued upon payment of the fee for registering and licensing a motor vehicle under § 27-14-601 An additional special license plate under subdivision (b)(1) of this section shall be issued:
(A) For a personal-use vehicle as defined under § 27-14612; and
(B) Except as provided in subsection (c), upon payment of the fee for registering and licensing a motor vehicle under § 27-14-601.
(c) An eligible applicant for the issuance or renewal of any of the following special license plates may obtain one (l) additional special license plate under this subchaptex upon payment of a fee not to exceed one dollar (\$1.00) and up to two (2) more additional special license plates under subdivision (b) (1) of this section:
(1) Pearl Harbor Survivor;
(2) Medal of Honor Recipient;
(3) Disabled Veteran;
(4) Disabled Veteran - World War I;
(5) Purple Heart Recipient; or
(6) A retired member of the United States Armed Forces under § 27-24-210.
(d)(1) Notwithstanding any law to the contrary, a fee shall not be charged for issuance and renewal of an ex-prisoner of war special license plate.
(2) An eligible applicant for the issuance or renewal of an exprisoner of war special license plate may obtain one (1) additional special license plate under this subchapter at no additional charge.
(e) An eligible applicant for the issuance or renewal of a military or veteran special license plate under this subchapter may elect to receive a standard Arkansas license plate instead of a military or veteran special license plate upon payment of one dollar (\$1.00).
