18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 SECTION 1. REAPPROPRIATION - ARKANSAS NORTHEASTERN COLLEGE. There is
21 hereby appropriated, to the Arkansas Northeastern College, to be payable from
22 the Development and Enhancement Fund, for the Arkansas Northeastern College
23 the following:

24 (A) Effective July 1, 2021, the balance of the appropriation provided
25 in Item (A) of Section 1 of Act 5 of 2020, for construction, renovation,
26 maintenance, critical maintenance, equipment, security enhancements,
27 technology upgrades/equipment and library resources of a Center for Science
28 and Technology, in a sum not to exceed\$1,850,000.

29 (B) Effective July 1, 2021, the balance of the appropriation provided
30 in Item (B) of Section 1 of Act 5 of 2020, for critical maintenance, in a sum
31 not to exceed\$290,000.

32 (C) Effective July 1, 2021, the balance of the appropriation provided
33 in Item (C) of Section 1 of Act 5 of 2020, for deferred maintenance, in a sum
34 not to exceed\$390,000.

35 (D) Effective July 1, 2021, the balance of the appropriation provided
36 in Item (D) of Section 1 of Act 5 of 2020, for repair or replacement of



1 equipment and library holdings, in a sum not to exceed\$140,140.

2
3 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - BEEBE. There
4 is hereby appropriated, to the Arkansas State University - Beebe, to be
5 payable from the Development and Enhancement Fund, for the Arkansas State
6 University - Beebe the following:

7 (A) Effective July 1, 2021, the balance of the appropriation provided
8 in Item (A) of Section 2 of Act 5 of 2020, for renovations of State Hall, in
9 a sum not to exceed\$1,375,000.

10 (B) Effective July 1, 2021, the balance of the appropriation provided
11 in Item (B) of Section 2 of Act 5 of 2020, for renovations of Owen Center, in
12 a sum not to exceed\$2,000,000.

13 (C) Effective July 1, 2021, the balance of the appropriation provided
14 in Item (C) of Section 2 of Act 5 of 2020, for critical maintenance, in a sum
15 not to exceed\$120,000.

16 (D) Effective July 1, 2021, the balance of the appropriation provided
17 in Item (D) of Section 2 of Act 5 of 2020, for deferred maintenance, in a sum
18 not to exceed\$1,050,000.

19 (E) Effective July 1, 2021, the balance of the appropriation provided
20 in Item (E) of Section 2 of Act 5 of 2020, for repair or replacement of
21 equipment and library holdings, in a sum not to exceed\$412,685.

22
23 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MID-SOUTH.
24 There is hereby appropriated, to the Arkansas State University - Mid-South,
25 to be payable from the Development and Enhancement Fund, for the Arkansas
26 State University - Mid-South the following:

27 (A) Effective July 1, 2021, the balance of the appropriation provided
28 in Item (A) of Section 3 of Act 5 of 2020, for upgrade and replacement of
29 Classroom Instructional Technology Equipment, in a sum not to exceed
30\$100,000.

31 (B) Effective July 1, 2021, the balance of the appropriation provided
32 in Item (B) of Section 3 of Act 5 of 2020, for critical maintenance, in a sum
33 not to exceed\$180,000.

34 (C) Effective July 1, 2021, the balance of the appropriation provided
35 in Item (C) of Section 3 of Act 5 of 2020, for deferred maintenance, in a sum
36 not to exceed\$470,000.

1 (D) Effective July 1, 2021, the balance of the appropriation provided
2 in Item (D) of Section 3 of Act 5 of 2020, for repair or replacement of
3 equipment and library holdings, in a sum not to exceed\$140,250.
4

5 SECTION 4. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - MOUNTAIN HOME.
6 There is hereby appropriated, to the Arkansas State University - Mountain
7 Home, to be payable from the Development and Enhancement Fund, for the
8 Arkansas State University - Mountain Home the following:

9 (A) Effective July 1, 2021, the balance of the appropriation provided
10 in Item (A) of Section 4 of Act 5 of 2020, for replacing critical maintenance
11 equipment, in a sum not to exceed\$1,000,000.
12

13 (B) Effective July 1, 2021, the balance of the appropriation provided
14 in Item (B) of Section 4 of Act 5 of 2020, for acquisition and renovation of
15 an Occupational Technical Center, in a sum not to exceed\$1,000,000.
16

17 (C) Effective July 1, 2021, the balance of the appropriation provided
18 in Item (C) of Section 4 of Act 5 of 2020, for construction, renovation,
19 maintenance, critical maintenance, equipment, security enhancements,
20 technology upgrades/equipment and library resources of a Health and Wellness
21 Center, in a sum not to exceed\$850,000.
22

23 (D) Effective July 1, 2021, the balance of the appropriation provided
24 in Item (D) of Section 4 of Act 5 of 2020, for deferred maintenance, in a sum
25 not to exceed\$260,000.
26

27 (E) Effective July 1, 2021, the balance of the appropriation provided
28 in Item (E) of Section 4 of Act 5 of 2020, for repair or replacement of
29 equipment and library holdings, in a sum not to exceed\$147,040.
30

31 SECTION 5. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - NEWPORT.
32 There is hereby appropriated, to the Arkansas State University - Newport, to
33 be payable from the Development and Enhancement Fund, for the Arkansas State
34 University - Newport the following:

35 (A) Effective July 1, 2021, the balance of the appropriation provided
36 in Item (A) of Section 5 of Act 5 of 2020, for construction, renovation,
37 maintenance, critical maintenance, equipment, security enhancements,
38 technology upgrades/equipment and library resources of a Classroom/Student
39 Services Building on the Jonesboro Campus, in a sum not to exceed
40\$1,000,000.

1 (B) Effective July 1, 2021, the balance of the appropriation provided
2 in Item (B) of Section 5 of Act 5 of 2020, for construction, renovation,
3 maintenance, critical maintenance, equipment, security enhancements,
4 technology upgrades/equipment and library resources of an Administration
5 Building on the Newport Campus, in a sum not to exceed\$1,000,000.

6 (C) Effective July 1, 2021, the balance of the appropriation provided
7 in Item (C) of Section 5 of Act 5 of 2020, for renovation and remodel of the
8 Main Building on the Jonesboro Campus, in a sum not to exceed\$850,000.

9 (D) Effective July 1, 2021, the balance of the appropriation provided
10 in Item (D) of Section 5 of Act 5 of 2020, for deferred maintenance, in a sum
11 not to exceed\$350,000.

12 (E) Effective July 1, 2021, the balance of the appropriation provided
13 in Item (E) of Section 5 of Act 5 of 2020, for repair or replacement of
14 equipment and library holdings, in a sum not to exceed\$279,520.

15
16 SECTION 6. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS.

17 There is hereby appropriated, to the Arkansas State University Three Rivers,
18 to be payable from the Development and Enhancement Fund, for the Arkansas
19 State University Three Rivers the following:

20 (A) Effective July 1, 2021, the balance of the appropriation provided
21 in Item (A) of Section 7 of Act 5 of 2020, for construction, renovation,
22 maintenance, critical maintenance, equipment, security enhancements,
23 technology upgrades/equipment and library resources of the Health/Science
24 Technology Building, in a sum not to exceed\$1,850,000.

25 (B) Effective July 1, 2021, the balance of the appropriation provided
26 in Item (B) of Section 7 of Act 5 of 2020, for construction, renovation,
27 maintenance, critical maintenance, equipment, security enhancements,
28 technology upgrades/equipment and library resources of the Conference and
29 Student Center, in a sum not to exceed\$1,000,000.

30 (C) Effective July 1, 2021, the balance of the appropriation provided
31 in Item (C) of Section 7 of Act 5 of 2020, for deferred maintenance, in a sum
32 not to exceed\$210,000.

33 (D) Effective July 1, 2021, the balance of the appropriation provided
34 in Item (D) of Section 7 of Act 5 of 2020, for repair or replacement of
35 equipment and library holdings, in a sum not to exceed\$117,495.

36

1 SECTION 7. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY THREE RIVERS -
2 RITZ THEATRE. There is hereby appropriated, to the Arkansas State University
3 Three Rivers, to be payable from the Arkansas Natural and Cultural Resources
4 Grant and Trust Fund, for the Arkansas State University Three Rivers the
5 following:

6 (A) Effective July 1, 2021, the balance of the appropriation provided
7 in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship
8 or preservation of state owned lands, historic sites, buildings, structures
9 or objects, in a sum not to exceed\$663,263.

10
11 SECTION 8. REAPPROPRIATION - BLACK RIVER TECHNICAL COLLEGE. There is
12 hereby appropriated, to the Black River Technical College, to be payable from
13 the Development and Enhancement Fund, for the Black River Technical College
14 the following:

15 (A) Effective July 1, 2021, the balance of the appropriation provided
16 in Item (A) of Section 6 of Act 5 of 2020, for the renovation of the "A" and
17 "B" Buildings, in a sum not to exceed\$157,500.

18 (B) Effective July 1, 2021, the balance of the appropriation provided
19 in Item (B) of Section 6 of Act 5 of 2020, for the construction of a storage
20 building for Fire Science Program truck and equipment, in a sum not to exceed
21\$157,500.

22 (C) Effective July 1, 2021, the balance of the appropriation provided
23 in Item (C) of Section 6 of Act 5 of 2020, for equipment replacement in the
24 Academic Complex/Library, in a sum not to exceed\$54,000.

25 (D) Effective July 1, 2021, the balance of the appropriation provided

27 building for Grounds Maintenance tractors and equipment, in a sum not to
28 exceed\$90,000.

4 not to exceed\$20,000.

5 (H) Effective July 1, 2021, the balance of the appropriation provided

7 not to exceed\$400,000.

8 (I) Effective July 1, 2021, the balance of the appropriation provided
9 in Item (I) of Section 6 of Act 5 of 2020, for repair or replacement of

11

12 SECTION 9. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE
13 UNIVERSITY OF ARKANSAS. There is hereby appropriated, to the Cossatot
14 Community College of the University of Arkansas, to be payable from the
15 Development and Enhancement Fund, for the Cossatot Community College of the
16 University of Arkansas the following:

17 (A) Effective July 1, 2021, the balance of the appropriation provided
18 in Item (A) of Section 8 of Act 5 of 2020, for upgrades to network technology
19 infrastructure, in a sum not to exceed\$600,000.

20 (B) Effective July 1, 2021, the balance of the appropriation provided
21 in Item (B) of Section 8 of Act 5 of 2020, for disaster recovery/business
22 continuity technology infrastructure, in a sum not to exceed\$60,000.

23 (C) Effective July 1, 2021, the balance of the appropriation provided
24 in Item (C) of Section 8 of Act 5 of 2020, for generator/backup power source
25 technology infrastructure, in a sum not to exceed\$40,000.

26 (D) Effective July 1, 2021, the balance of the appropriation provided
27 in Item (D) of Section 8 of Act 5 of 2020, for maintenance related to
28 heating, ventilation, and air conditioning for building system failure, in a
29 sum not to exceed\$60,000.

30 (E) Effective July 1, 2021, the balance of the appropriation provided

4 SECTION 10. REAPPROPRIATION - COSSATOT COMMUNITY COLLEGE OF THE
5 UNIVERSITY OF ARKANSAS - LOCKESBURG MIDDLE SCHOOL RESTORATION. There is
6 hereby appropriated, to the Cossatot Community College of the University of
7 Arkansas, to be payable from the Arkansas Natural and Cultural Resources
8 Grant and Trust Fund, for the Cossatot Community College of the University of
9 Arkansas the following:

10 (A) Effective July 1, 2021, the balance of the appropriation provided
11 in Section 27 of Act 18 of 2020, for the acquisition, management, stewardship
12 or preservation of state owned lands, historic sites, buildings, structures
13 or objects, in a sum not to exceed\$336,525.

14
15 SECTION 11. REAPPROPRIATION - EAST ARKANSAS COMMUNITY COLLEGE. There
16 is hereby appropriated, to the East Arkansas Community College, to be payable
17 from the Development and Enhancement Fund, for the East Arkansas Community
18 College the following:

19 (A) Effective July 1, 2021, the balance of the appropriation provided
20 in Item (A) of Section 9 of Act 5 of 2020, for construction, renovation,
21 maintenance, critical maintenance, equipment, security enhancements,
22 technology upgrades/equipment and library resources, in a sum not to exceed
23\$250,000.

24 (B) Effective July 1, 2021, the balance of the appropriation provided
25 in Item (B) of Section 9 of Act 5 of 2020, for deferred maintenance, in a sum
26 not to exceed\$150,000.

27 (C) Effective July 1, 2021, the balance of the appropriation provided
28 in Item (C) of Section 9 of Act 5 of 2020, for transfers of or refund to
29 expenditures for capital balances for construction, renovation, major
30 maintenance, and purchase of equipment for various capital projects or
31 facility improvements, in a sum not to exceed\$390,591.

32 (D) Effective July 1, 2021, the balance of the appropriation provided

26 infrastructure, in a sum not to exceed\$1,591,000.

27 (C) Effective July 1, 2021, the balance of the appropriation provided

29 Fisher Center, in a sum not to exceed\$1,049,600.

30 (D) Effective July 1, 2021, the balance of the appropriation provided

12\$23,800.

13 (B) Effective July 1, 2021, the balance of the appropriation provided
14 in Item (B) of Section 11 of Act 5 of 2020, for renovation and replacement of
15 sliding glass doors, in a sum not to exceed\$100,000.

16 (C) Effective July 1, 2021, the balance of the appropriation provided
17 in Item (C) of Section 11 of Act 5 of 2020, for renovation of tiered
18 classrooms to comply with the Americans with Disabilities Act, in a sum not
19 to exceed\$75,000.

11 (A) Effective July 1, 2021, the balance of the appropriation provided
12 in Item (A) of Section 12 of Act 5 of 2020, for construction, renovation,
13 maintenance, critical maintenance, equipment, security enhancements,
14 technology upgrades/equipment and library resources of the Washington County
15 Center, in a sum not to exceed\$1,000,000.

16 (B) Effective July 1, 2021, the balance of the appropriation provided
17 in Item (B) of Section 12 of Act 5 of 2020, for construction, renovation,
18 maintenance, critical maintenance, equipment, security enhancements,
19 technology upgrades/equipment and library resources of the new Physical Plant
20 facility, in a sum not to exceed\$1,000,000.

21 (C) Effective July 1, 2021, the balance of the appropriation provided
22 in Item (C) of Section 12 of Act 5 of 2020, for purchase of the former
23 railroad property, in a sum not to exceed\$621,000.

24 (D) Effective July 1, 2021, the balance of the appropriation provided

26 drainage, leveling and replanting for the grounds covered by the railroad

21 agencies listed herein shall have the authority to accept and use grants and
22 donations including Federal funds, and to use its unobligated cash income or
23 funds, or both available to it, for the purpose of supplementing the State
24 Treasury funds for financing the entire costs of the project or projects
25 enumerated herein. Provided further, that the appropriations and funds
26 otherwise provided by the General Assembly for Maintenance and General
27 Operations of the agency or institutions receiving appropriation herein shall
28 not be used for any of the purposes as appropriated in this act.

29 (B) The restrictions of any applicable provisions of the State
30 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
31 Revenue Stabilization Law and any other applicable fiscal control laws of

1 SECTION 30. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this act shall be in compliance with the stated reasons for
4 which this act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.
9

10 SECTION 31. EMERGENCY CLAUSE. It is found and determined by the
11 General Assembly, that the Constitution of the State of Arkansas prohibits
12 the appropriation of funds for more than a one (1) year period; that the
13 effectiveness of this Act on July 1, 2021 is essential to the operation of
14 the agency for which the appropriations in this Act are provided, and that in
15 the event of an extension of the legislative session, the delay in the
16 effective date of this Act beyond July 1, 2021 could work irreparable harm
17 upon the proper administration and provision of essential governmental
18 programs. Therefore, an emergency is hereby declared to exist and this Act
19 being necessary for the immediate preservation of the public peace, health
20 and safety shall be in full force and effect from and after July 1, 2021.
