Arkansas Code § 6-15-503, concerning prerequisites to home 22 schooling, is amended to add an additional subsection to read as follows: 23 (f)(1) A student who is enrolled in a public school and who has been temporarily issued items, resources, supplies, materials, or other property 24 25 belonging to the public school at which he or she is enrolled is eligible for 26 enrollment in a home school after: 27 (A) The items, resources, supplies, materials, or other property belonging to the public school district at which the student is 28 29 enrolled have been returned to the public school; 30 (B) The items, resources, supplies, materials, or other property belonging to the public school district at which the student is 31 32 enrolled have been paid for; or 33 (C) The semester has ended. 34 (2) However, the public school district superintendent or the 35 local school district board of directors may waive the required five (5) 36 calendar day waiting period required under subdivision (a)(1)(B) of this
