28	SECTION 1. Arkansas Code § 6-15-509(c)(1)(B), concerning a		
29	homeschooled student participating in interscholastic activities at a public		
30	school other than the student's resident school, is amended to read as		
31	follows:		
32	(B) <u>(i)</u> A home-schooled <u>homeschooled</u> stude	ent may
33	participate in inter	scholastic activities at a public school	l other than the
34	home-schooled homeschooled student's resident school by mutual agreement		
35	between the resident school and any other public school where the home-		
36	schooled homeschooled student wishes to participate.

1	(ii) Approval by the resident school as required		
2	under subdivision (c)(l)(B)(i) of this section is not required if the		
3	interscholastic activity in which the homeschooled student intends to		
4	participate is not offered by the resident school.

6	SECTION 2. Arkansas Code §§ 6-15-509(g) and (h), concerning a		
7	homeschooled student participating in interscholastic activities at a public		
8	school, are amended to read as follows:		
9	(g) A home-schooled <u>homeschooled</u> student who participates in an		
10	interscholastic activity may be :		
11	(1) Required <u>Shall not be required</u> to be at school not more than		
12	one (1) period per school day for any purpose not directly related to the		
13	interscholastic activity in which he or she participates; and		
14	(2) Transported <u>May be transported</u> by the resident school		
15	district to and from interscholastic activities as the resident school		
16	district transports other students who are enrolled in the resident school.		
17	(h) A student who withdraws from an Arkansas Activities Association		
18	member school to be home-schooled <u>homeschooled</u> shall not participate in an		
19	interscholastic activity in the resident school district for a minimum of		
20	three hundred sixty-five (365) days after the student withdraws from the		
21	member school.		
22			
23	SECTION 3. Arkansas Code § 6-15-509, concerning participation of home-		
24	schooled students in interscholastic activities, is amended to add an		
25	additional subsection to read as follows:		
26	(j) There shall be no additional criteria or requirements for a home-		
27	schooled student to participate in an interscholastic activity beyond what is		
28	provided by this section.
