1	SECTION 2. Arkansas Code § 26-37-201(a)(1), concerning publication of		
2	notice by the Commissioner of State Lands, is amended to read as follows:		
3	(a)(1)(A) The Commissioner of State Lands shall publish a notice of		
4	sale of land upon which the ad valorem property taxes have not been paid in a		
5	newspaper having general circulation in the county where the land is located.		
6	(B) As used in this subchapter, "a newspaper having		
7	general circulation in the county" shall include a newspaper published:		
8	(i) On paper;		
9	(ii) Electronically; or		
10	(iii) In a combination of paper and electronically.		
11			
12	SECTION 3. Arkansas Code § 26-37-301(c), concerning the notice to an		
13	owner and definitions for the redemption of realty to be sold for taxes, is		
14	amended to read as follows:		
15	(c) As used in this section, <u>subchapter:</u>		
16	(1)(A) <u>"owner</u> " <u>"Owner"</u> and "interested party" mean any person,		
17	firm, corporation, or partnership holding title to or an interest in the tax-		
18	delinquent land by virtue of a bona fide recorded instrument at the time of		
19	certification to the Commissioner of State Lands.		
20	(B) "Owner" includes:		
21	(i) Every owner of the property if the property is		
22	owned by joint tenants; and		
23	(ii) Either the husband or the wife if the property		
24	is owned by tenants by the entirety; and		
25	(2) "Redeemer" means:		
26	(A) The owner of the property who redeems the property by		
27	paying all taxes, penalties, interest, and costs; or		
28	(B) Any other person, firm, corporation, or partnership		
29	without an existing ownership interest in the property who redeems the		
30	property by paying all taxes, penalties, interest, and costs.

32	SECTION 4. Arkansas Code § 26-37-303 is amended to read as follows:		
33	26-37-303. Redemption deed.		
34	(a) If the owner <u>or redeemer</u> redeems the tax-delinquent land, the		
35	Commissioner of State Lands shall issue a redemption deed in the name of the		
36	owner or redeemer and record it in the county wherein the land is located.

1	(b) A redemption deed shall:
2	(1) Serve as proof that payment under § 26-37-302 has been
3	received by the Commissioner of State Lands; and
4	(2) Not convey or change the legal ownership to the property
5	redeemed.
6	(c) The fee for the redemption deed and the fee for recording the deed
7	shall be borne by the owner <u>or redeemer</u> .
