4	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of	funds				
5	authorized by this act shall be limited to the appropriation	for such agency				
6	and funds made available by law for the support of such appro	priations; and				
7	the restrictions of the State Procurement Law, the General Ac	counting and				
8	Budgetary Procedures Law, the Revenue Stabilization Law, the	Regular Salary				
9	Procedures and Restrictions Act, or their successors, and oth	er fiscal				
10	control laws of this State, where applicable, and regulations	promulgated by				
11	the Department of Finance and Administration, as authorized b	y law, shall be				
12	strictly complied with in disbursement of said funds.

14	SECTION 3. LEGISLATIVE INTENT. It is the intent of the	General				
15	Assembly that any funds disbursed under the authority of the	appropriations				
16	contained in this act shall be in compliance with the stated	reasons for				
17	which this act was adopted, as evidenced by the Agency Reques	ts, Executive				
18	Recommendations and Legislative Recommendations contained in	the budget				
19	manuals prepared by the Department of Finance and Administrat	ion, letters, or				
20	summarized oral testimony in the official minutes of the Arka	nsas Legislative				
21	Council or Joint Budget Committee which relate to its passage	and adoption.

23	SECTION 4. EMERGENCY CLAUSE. It is found and determine	d by the General				
24	Assembly, that funds provided by the General Assembly for the	operations of				
25	the North Arkansas College are, due to unforeseen circumstance	es, insufficient				
26	for the North Arkansas College to continue to provide essenti	al governmental				
27	services; that the provisions of this act will provide the ne	cessary monies				
28	for the North Arkansas College to continue such services; and	that a delay in				
29	the effective date of this Act could work irreparable harm up	on the proper				
30	administration and provision of essential governmental progra	ms. Therefore,				
31	an emergency is hereby declared to exist and this Act being n	ecessary for the				
32	immediate preservation of the public peace, health and safety	shall be in				
33	full force and effect from and after the date of its passage	and approval.				
34	If the bill is neither approved nor vetoed by the Gover	nor, it shall				
35	become effective on the expiration of the period of time duri	ng which the				
36	Governor may veto the bill. If the bill is vetoed by the Gov	ernor and the				

1	<u>veto is overridden,</u>	it	shall	become	effective	on	the	date	the	last	house
2	overrides the veto.
