## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 FOR THE ARKANSAS NORTHEASTERN COLLEGE WHICH SHALL BE  
10 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
11 APPROPRIATED BY ACT 22 OF 2020; AND FOR OTHER  
12 PURPOSES.

## Subtitle

15 AN ACT FOR THE ARKANSAS NORTHEASTERN  
16 COLLEGE SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby  
23 appropriated, to the Arkansas Northeastern College, to be payable from the  
24 Arkansas Northeastern College Fund, for personal services of the Arkansas  
25 Northeastern College which shall be supplemental and in addition to those  
26 funds appropriated in Section 3 of Act 22 of 2020, the following:

32 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
33 authorized by this act shall be limited to the appropriation for such agency  
34 and funds made available by law for the support of such appropriations; and  
35 the restrictions of the State Procurement Law, the General Accounting and  
36 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary



1 Procedures and Restrictions Act, or their successors, and other fiscal  
2 control laws of this State, where applicable, and regulations promulgated by  
3 the Department of Finance and Administration, as authorized by law, shall be  
4 strictly complied with in disbursement of said funds.

5  
6 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General  
7 Assembly that any funds disbursed under the authority of the appropriations  
8 contained in this act shall be in compliance with the stated reasons for  
9 which this act was adopted, as evidenced by the Agency Requests, Executive  
10 Recommendations and Legislative Recommendations contained in the budget  
11 manuals prepared by the Department of Finance and Administration, letters, or  
12 summarized oral testimony in the official minutes of the Arkansas Legislative  
13 Council or Joint Budget Committee which relate to its passage and adoption.

14  
15 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
16 Assembly, that funds provided by the General Assembly for the operations of  
17 the Arkansas Northeastern College are, due to unforeseen circumstances,  
18 insufficient for the Arkansas Northeastern College to continue to provide  
19 essential governmental services; that the provisions of this act will provide  
20 the necessary monies for the Arkansas Northeastern College to continue such  
21 services; and that a delay in the effective date of this Act could work  
22 irreparable harm upon the proper administration and provision of essential  
23 governmental programs. Therefore, an emergency is hereby declared to exist  
24 and this Act being necessary for the immediate preservation of the public  
25 peace, health and safety shall be in full force and effect from and after the  
26 date of its passage and approval.

27 If the bill is neither approved nor vetoed by the Governor, it shall  
28 become effective on the expiration of the period of time during which the  
29 Governor may veto the bill. If the bill is vetoed by the Governor and the  
30 veto is overridden, it shall become effective on the date the last house  
31 overrides the veto.
