23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24 25	SECTION 1. DO NOT CODIFY. Title.

20 27	This act shall be known and may be cited as the "Personal Care Medicaid Reimbursement Act".
28	Keimbursement Act .
29	SECTION 2. Arkansas Code § 20-77-115 is amended to read as follows:
30	20-77-115. Personal care reimbursement rates — <u>Legislative findings</u> —
31	Definition.
32	(a) The General Assembly finds that:
33	(1) The provision of high-quality personal care services in
34	Arkansas is a priority concern;
35	(2) Personal care service:
36	(A) Is an essential service that enables residents of

1	Arkansas to live in their own homes and avoid institutional care;
2	(B) Is vital for allowing residents of Arkansas to remain
3	in their own homes and maintain a level of personal independence and freedom;
4	<u>and</u>
5	(C) Saves the healthcare system money by avoiding
6	prolonged institutionalization, high costs, and associated adverse
7	implications; and
8	(3) Providers of personal care services should be paid at a rate
9	that is consistent with efficiency, economy, and quality of care and is
10	sufficient to enlist enough providers so that in-home care and services are
11	available statewide.
12	(b) As used in this section, "personal care services" means assistance
13	with activities of daily living, respite care, or attendant care provided in
14	the home through the Arkansas Medicaid Personal Care Program.
15	(c)(1) Personal care reimbursement rates shall be established at
16	twelve dollars and thirty-five cents (\$12.35) per unit or at lesser amounts
17	as may be established for a program of client-directed personal care which
18	${\tt may}$ be developed and implemented by the Department of Human Services ${\tt If}$ there
19	is an increase in the state or federal minimum wage that is higher than the
20	minimum wage that applies to employees in Arkansas, the Arkansas Medicaid
21	Program shall conduct a review of the reimbursement rates for personal care
22	services within one hundred eighty (180) days of the publishing of the rate
23	by the Department of Labor and Licensing.
24	(2) Within one hundred eighty (180) days of the completion of
25	the review of the reimbursement rates under subdivision (c)(1) of this
26	section, the Department of Human Services shall submit a state plan
27	amendment, waiver, or other necessary authorization to modify the
28	reimbursement rate of personal care services.
29	(3) The reimbursement rate modifications described in
30	subdivision (c)(2) of this section shall be retroactive to the maximum date
31	of the increase in the state or federal minimum wage that is allowable under
32	federal law as it relates to the federal medical assistance percentage.
33	(d) A reimbursement payment made under this section may not exceed the
34	Medicaid upper payment limit as established by the Centers for Medicare $\&$
35	Medicaid Services.
36	(e) The program shall make sufficient funds available to a beneficiary

1	to reimburse or pay a provider of personal care services for the number of
2	hours of personal care services that the beneficiary needs or is qualified or
3	eligible for.
