20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. DO NOT CODIFY. <u>Legislative findings.</u>
23	(a)(1) The General Assembly finds that Arkansas Constitution, Article
24	2, § 8, provides that "[a]ll persons shall, before conviction, be bailable by
25	sufficient sureties, except for capital offenses, when the proof is evident
26	or the presumption great."
27	(2) This policy enshrines and enforces the presumption of
28	innocence central to the American system of justice.
29	(b) However, the General Assembly also finds that imposition of a
30	requirement that a person who is presumed innocent pay for his or her freedom
31	before adjudication is in tension with this provision and has the potential
32	for abuse.
33	(c) The General Assembly therefore finds that the law should address
34	and adopt methods to reduce the likelihood of deprivation of the rights of a
35	person presumed to be innocent.

1	SECTION 2. Arkansas Code § 16-81-109 is amended to read as follows:
2	16-81-109. Release from custody — Bail or citation.
3	(a)(l) When any sheriff or other law enforcement officer makes an
4	arrest, he or she is authorized to take and to approve bail in the manner
5	provided by law wherever he or she makes the arrest For a felony offense, a
6	judicial officer shall set cash or money bail only after he or she determines
7	that no other conditions will reasonably ensure the appearance of the
8	defendant in court.
9	(2) (A) If the offense charged is a misdemeanor, the person
10	arrested may immediately give bail for appearing on a day to be named in the
11	bail bond before the judge or magistrate who issued the warrant or before the
12	court having jurisdiction to try the offense. The sheriff or other officer
13	making the arrest may be authorized by the judge or magistrate issuing the
14	warrant to take the bail by an endorsement made on the warrant to that effect
15	For a misdemeanor offense, there shall be a rebuttable presumption that the
16	arresting officer shall issue an electronic citation or prepare in duplicate
17	a written citation to appear in court containing:
18	(i) The name and address of the person;
19	(ii) The driver's license, state identification, or
20	passport number of the person;
21	(iii) The offense charged; and
22	(iv)(a) The time and location of the person's court
23	date, including the court's contact information.
24	(b) The time specified to appear shall be at
25	least five (5) days after the issuance of the citation.
26	(c) The location specified to appear shall be
27	before a district court judge with jurisdiction within the county in which
28	the offense charged is alleged to have been committed.
29	(B) If issued a written citation, the arrested person
30	shall give his or her written promise to appear in court by signing in
31	duplicate the written citation prepared by the arresting officer.
32	(C) If issued an electronic citation, the arrested person
33	shall acknowledge receipt of the electronic citation and give his or her
34	promise to appear in court by acceptance of the electronic citation.
35	(D) The original of the citation shall be retained by the
36	officer or electronically transmitted to the district court, and a copy of

1	the citation shall be delivered to the person arrested.
2	(3) For a misdemeanor offense, the rebuttable presumption may be
3	overcome by clear and convincing evidence, duly documented and recorded by
4	law enforcement, that the defendant has a history of willful and intentional
5	failure to appear for the purpose of absconding from the jurisdiction of the
6	court within the last two (2) years, or that he or she presents an imminent
7	and identifiable threat to a specific person or persons.
8	(4) Cash or money bail in any form for ordinance violations is
9	prohibited.
10	(b) Cash or money bail in any form is considered only a last resort
11	and shall be used only to assure the defendant's appearance.
12	$\frac{(b)(1)}{(c)(1)}$ If the defendant gives bail for his or her appearance
13	before the judge or magistrate for an examination of the charge, as provided
14	in subsection (a) of this section, the county sheriff or officer taking the
15	bail shall fix the day of the defendant's appearance.
16	(2) A deviation from the provisions of subdivision $\frac{(b)(1)}{(c)(1)}$
17	of this section shall not, however, render the bail bond invalid.
18	(d) As used this section, "compelling circumstances" means that:
19	(1) Within the previous two (2) years, the person has a
20	documented history of willfully or intentionally failing to appear in court;
21	(2) The person at any time previously absconded from the
22	jurisdiction of the court; or
23	(3) The person presents an imminent, identifiable threat to a
24	specific person or persons if he or she remains out of custody.
