27	Act of 1967, is amended to add additional subdivisions to read as follows:
28	(27) Records that have been made part of a criminal
29	investigation by and that are in the custody of a law enforcement entity that
30	is subject to this subchapter, to the extent that disclosure would constitute
31	a clearly unwarranted invasion of the personal privacy of:
32	(A) The victim;
33	(B) A member of the victim's family if the family member has not
34	been:
35	(i) Charged with or convicted of the crime; or
36	(ii) Publically identified as a suspect in the crime by

3	(28) Personal contact information in the custody of a law
