27	SECTION 1. Arka	nsas Code § 20-78-202(2)(A)(ii),	concerning the
28	definition of "childcan	re facility" as it relates to th	e Childcare Facility
29	Licensing Act, is amend	ded to read as follows:	
30		(ii) For the purposes of this	subdivision (2),
31	"related minor child" n	neans a minor child <u>:</u>

4	SECTION 2. Arkansas Code Title 20, Chapter 78, Subchapter 2, is		
5	amended to add an additional section to read as follows:		
6	20-78-229. Educational requirements.		
7	(a) The Division of Child Care and Early Childhood Education shall not		
8	impose minimum postsecondary education requirements higher than a high school		
9	diploma or four (4) years of experience in a related field and the		
10	requirements of § 20-78-222 as a prerequisite to being a director at a		
11	childcare facility.		
12	(b)(1) The division shall not impose minimum postsecondary education		
13	requirements higher than a high school diploma or GED as a prerequisite to		
14	work or volunteer at a childcare facility.		
15	(2) Notwithstanding the provisions of state law, to the extent a		
16	staff member in a childcare facility or home-based childcare arrangement is		
17	required to meet minimum postsecondary educational requirements, the division		
18	shall consider a staff member who is enrolled and working toward meeting the		
19	minimum postsecondary educational requirements as having met the minimum		
20	requirements for as long as the staff member is actively enrolled.
