7	(C) "Bingo equipment" is not intended and shall not be		
8	construed to permit the participants to play the game of bingo through:		
9	(i) Any electronic device or machine except an		
10	electronic bingo device as defined in subdivision (8) of this section; or		
11	(ii) A pull-tab bingo ticket.		
12	(D) "Bingo equipment" does not include:		
13	(i) A bingo game game of bingo set commonly		
14	manufactured and sold as a child's game for a retail price of twenty dollars		
15	(\$20.00) or less, unless the set or a part of the set is used in a game of		
16	bingo subject to regulation under this chapter; or		
17	(ii) A commonly available component part of bingo		
18	equipment such as a light bulb or fuse;		
19	(3)(A) "Bingo face" means a disposable flat piece of paper or		
20	electronic facsimile of a paper bingo sheet that may:		
21	(i) May be used one (1) time and that cannot be		
22	reused after the game in which the bingo face was used has ended. The bingo		
23	face is; and		
24	(ii) Is marked off into any number of squares in any		
25	arrangement of rows, with each square being designated by number, letter, or		
26	combination of numbers and letters, and with one (1) or more squares		
27	designated as a "free" space <u>.</u>		
28	(B) "Bingo face" includes a disposable flat piece of paper		
29	with braille markings for visually impaired participants;		
30	(4) "Bingo session" means all activities incidental to the		
31	conduct of a series of games of bingo by a licensed authorized organization,		
32	beginning when the first game of bingo of a bingo session is commenced by		
33	calling the first bingo ball drawn, such session not to exceed five (5)		
34	consecutive hours during any one (1) twenty-four-hour calendar day;		
35	(5) "Charitable purpose" means a purpose described by § 23-114-		
36	504:

5	sells, markets, or otherwise provides bingo equipment to a licensed		
6	authorized organization;		
7	(8)(A) "Electronic bingo device" means a handheld or portable		
8	electronic device that requires a coded entry to activate play against other		
9	players in a game of bingo and that is used by a player of a game of bingo		
10	<u>to:</u>		
11	(i) Monitor an electronic facsimile of a paper bingo		
12	sheet purchased and played at the same time and place as an authorized		
13	organization's game of bingo;		
14	(ii) Activate numbers announced or displayed and to		
15	compare the numbers to the bingo faces previously stored in the memory of the		
16	device; and		
17	(iii) Identify a winning game of bingo pattern.		
18	(B) "Electronic bingo device" does not include an		
19	electronic device that:		
20	(i) Allows play of more than fifty (50) bingo faces		
21	per game of bingo;		
22	(ii) Allows the use of a coin, currency, token, or		
23	electronic funds transfer to be inserted to activate play;		
24	(iii) Has any additional function as an amusement or		
25	gambling device; or		
26	(iv) Allows the game of bingo to be played from a		
27	location other than the physical location where the game of bingo is being		
28	conducted.		
29	(C) An electronic bingo device shall:		
30	(i) Have the capability to ensure adequate levels of		
31	internal security controls as determined by the Secretary of the Department		
32	of Finance and Administration; and		
33	(ii) Be purchased or leased by a licensed authorized		
34	organization from a distributor licensed under this chapter;		
35	(9)(A) "Game of bingo" means a single game of the activity		
36	commonly known as "bingo" in which the participants pay a sum of money for		

- 1 the use of one (1) or more bingo faces.
- 2 (B) "Game of bingo" includes only a game in which the:
- 3 <u>(i) Game is conducted from and all participants are</u>
- 4 located in a single physical location; and
- 5 (ii) winner Winner receives a preannounced, fixed-
- 6 dollar prize and in which the winner is determined by the matching of letters
- 7 and numbers on a bingo face imprinted or displayed electronically with at
- 8 least twenty-four (24) numbers, with letters and numbers appearing on objects
- 9 randomly drawn and announced by a caller, in contemporaneous competition
- 10 among all players in the game;
- 11 (10) "Gross receipts" means the total amount received from the
- 12 sale of raffle tickets and the sale, rental, transfer, or use of bingo faces
- 13 and entrance fees charged at premises at which games of bingo or raffles are
- 14 conducted without any deduction on account of prizes paid, losses, or any
- 15 other expenses whatsoever;
- 16 (11) "Licensed authorized organization" means an authorized
- 17 organization that holds a license to conduct games of bingo or raffles;
- 18 (12) "Manufacturer" means a person or business entity that
- 19 produces finished bingo equipment from raw materials, supplies, or subparts
- 20 and that sells, markets, or otherwise provides such equipment to a licensed
- 21 distributor;
- 22 (13) "Person" means any individual, company, partnership,
- 23 limited liability company, joint venture, joint agreement, association,
- 24 mutual or otherwise, corporation, estate, trust, business trust, receiver,
- 25 trustee, syndicate, or any other private entity;
- 26 (14)(A) "Premises" means the area subject to the direct control
- 27 of and actual use by a licensed authorized organization to conduct games of
- 28 bingo.
- 29 <u>(B)</u> "Premises" includes a location or place;
- 30 (15) "Primary business office" means the Arkansas location at
- 31 which all records relating to the primary purpose of a licensed authorized
- 32 organization are maintained in the ordinary course of business;
- 33 (16)(A) "Raffle" means the selling of tickets to win a prize
- 34 awarded through a random drawing.
- 35 (B) "Raffle" does not include any game played through the

36 use of a machine or electronic device; and

1	(17) "Responsible person" means the person or persons within a		
2	licensed authorized organization that are responsible for organizing,		
3	conducting, and otherwise administering the licensed authorized		
4	organization's raffles or bingo sessions.		
5			
6	SECTION 2. Arkansas Code § 23-114-103(c), concerning the play of games		
7	of bingo or raffles, is amended to read as follows:		
8	(c) The provisions of this chapter are not intended and shall not be		
9	construed to allow the play of games of bingo or raffles through any		
10	electronic device or machine.		
11			
12	SECTION 3. Arkansas Code § 23-114-202 is amended to read as follows:		
13	23-114-202. Approval of bingo faces and raffle tickets.		
14	(a) The Secretary of the Department of Finance and Administration by		
15	rule shall provide for the form of bingo faces and raffle tickets used in the		
16	State of Arkansas.		
17	(b)(1) All bingo faces $\frac{\text{must}}{\text{must}}$ be purchased by the licensed		
18	authorized organization from a distributor licensed under this chapter.		
19	(2) Only one (1) game of bingo shall be played on each bingo		
20	face.		
21	(c)(1) All bingo faces and raffle tickets shall be preprinted on paper		
22	or plastic or loaded electronically to an electronic bingo device.		
23	(2) Electronic devices, machines, or facsimiles shall not be		
24	used as bingo faces, raffle tickets , or otherwise, by participants of games		
25	of bingo or raffles conducted under this chapter.		
26	(d) All bingo faces and raffle tickets shall be sequentially numbered		
27	at the time of <u>generation or</u> printing.		
28	(e) All electronic bingo devices shall be inspected and approved by		
29	the secretary before use in a game of bingo.		
30	(f) All forms of electronic facsimiles of paper bingo sheets shall be		
31	approved by the secretary.
