6	electronically.		
7	(b)(1) A casino operating under the authority of The Arkansas Casino		
8	Gaming Amendment of 2018, Arkansas Constitution, Amendment 100, and making		
9	payments of gambling winnings that are subject either to withholding or		
10	backup withholding under 26 U.S.C. § 3402, as in effect on January 1, 2021,		
11	or 26 U.S.C. § 3406, as in effect on January 1, 2021, shall also withhold		
12	Arkansas income tax on the same payments of gambling winnings.		
13	(2) Arkansas income tax shall be withheld from the payment of		
14	gambling winnings under subdivision (b)(1) of this section at the rate of		
15	five and nine-tenths percent (5.9%) or the highest income tax rate imposed on		
16	individual taxpayers under § 26-51-201, whichever is less.		
17	(3)(A) The amounts withheld by a casino under this subsection		
18	shall be remitted to the secretary electronically on or before the fifteenth		
19	day of the month following payment of the gambling winnings by the casino.		
20	(B) The secretary shall provide a method for casinos to		
21	report and pay amounts withheld under this subsection to the secretary		
22	electronically.
