16	(2) A state-supported two-year or four-year institution of		
17	higher education may include on an identification card or identification		
18	badge instructions for contacting a text-based state or national organization		
19	that provides free support to individuals in crisis twenty-four (24) hours a		
20	day and seven (7) days a week.
