27	county and municipal officers, is amended to add additional subdivisions to

27	candidate for the position of mayor; or		
28	(ii) Dies.		
29	(D) If a candidate withdraws or dies prior to the runoff		
30	election, the remaining candidate for the position of mayor shall be declared
