27	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL
28	ASSEMBLY OF THE STATE OF ARKANSAS:
29	
30	(a) That the Regular Session of the Ninety-Third General Assembly of
31	the State of Arkansas reconvened, following an extended recess, on September
32	29, 2021;
33	(b) That under Arkansas Constitution, Article 6, § 15, prior to
34	adjournment of the General Assembly, the Governor is afforded five (5) days
35	after receipt of a bill to sign a bill or veto a bill, therefore from October
36	8, 2021, to October 15, 2021, the House of Representatives and the Senate

2	Representatives and the office of the Secretary of the Senate may receive
3	communications, vetoes of bills by the Governor, and notification of errors
4	and oversights;
5	(c) That the Regular Session of the Ninety-Third General Assembly of
6	the State of Arkansas shall enter into recess simultaneously at the close of
7	business in each chamber on October 8, 2021, or at such earlier time as may
8	be agreed upon by the House of Representatives and the Senate;
9	(d) That the Speaker of the House of Representatives and the President
10	Pro Tempore of the Senate may, by joint proclamation:
11	(1) Reconvene the General Assembly at any time before 12:00
12	noon, October 15, 2021, for the purpose of:
13	(A) Considering vetoes; and
14	(B) Correcting errors and oversights; or
15	(2) Adjourn the Regular Session of the Ninety-Third General
16	Assembly at any time before 12:00 noon, October 15, 2021, if they determine
17	it is not necessary to reconvene; and
18	(e) That if the General Assembly is not reconvened or adjourned before
19	12:00 noon, October 15, 2021, the Regular Session of the Ninety-Third General
20	Assembly is adjourned sine die on that date.
